Support Motion**

On November 7, 2019 the Empowerment Congress North Area Neighborhood Development Council (NANDC) reviewed the Motion presented by Councilmembers Ryu, Harris-Dawson and Wesson, and voted to support the Council File 17-0117 Motion that:

The Council instruct the Planning Department in consultation with the City Attorney to prepare a report within 60 days on the feasibility of establishing a process to create *Alcohol Restricted Use Subdistricts (ARUS)*.

On October 22, the NANDC Policy Committee heard a presentation by Los Angeles Drug and Alcohol Policy Alliance regarding this land use tool, ARUS, which is designed to allow the end user to gauge and limit the number of alcohol retailers entering our communities. The Committee recommended unanimously (5-0-0) that the NANDC Board support the Motion and file a CIS.

The matter was placed on the NANDC November 7, 2019 duly noticed General Board Meeting Agenda, VII. Motions & Resolutions, item i. The NANDC Board voted to support the CF-0117 Motion by a vote of 13 ayes, 0 nays and 0 abstentions.
