Current Master On-Sale Licenses & Applications City of Los Angeles by Council District



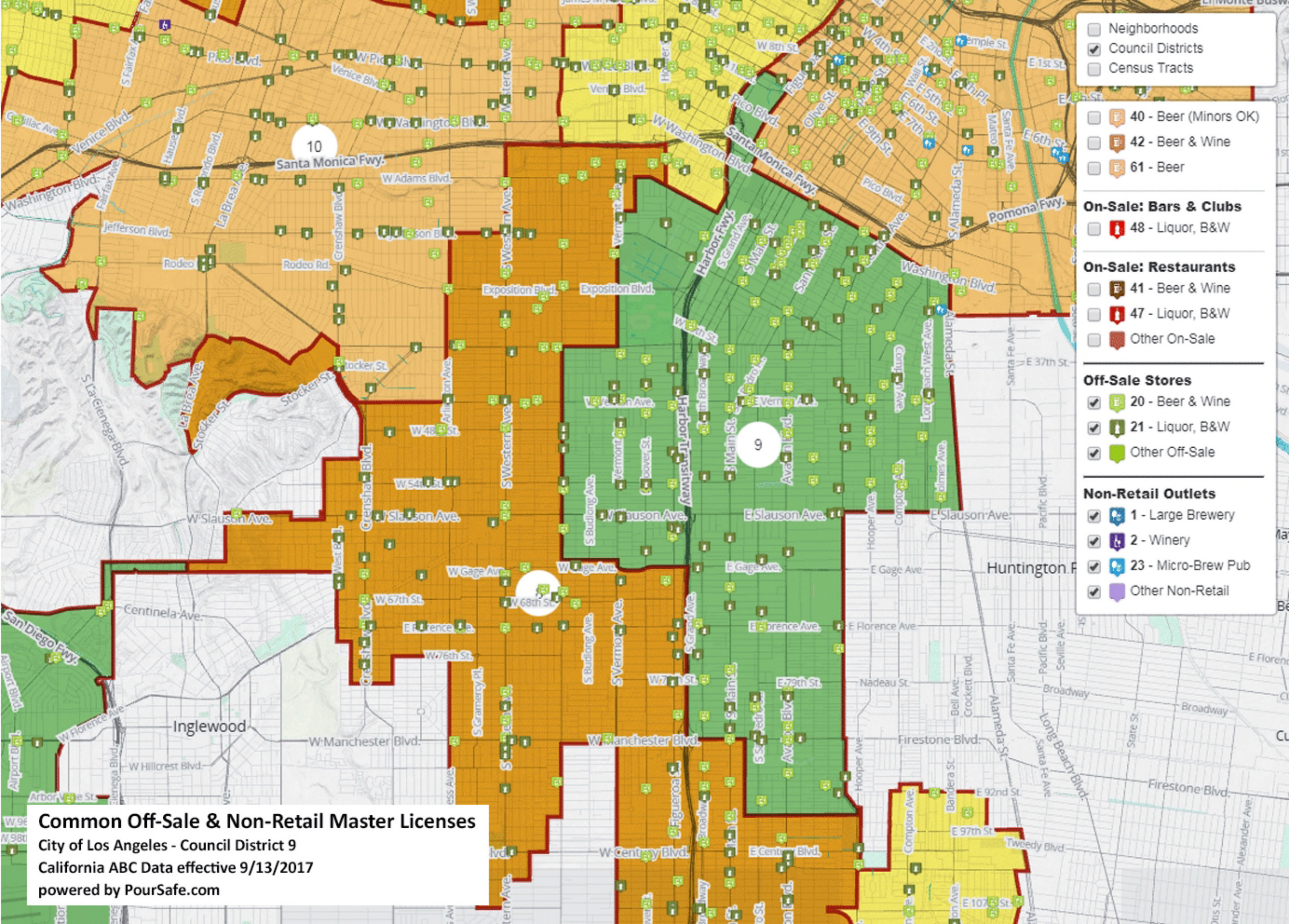

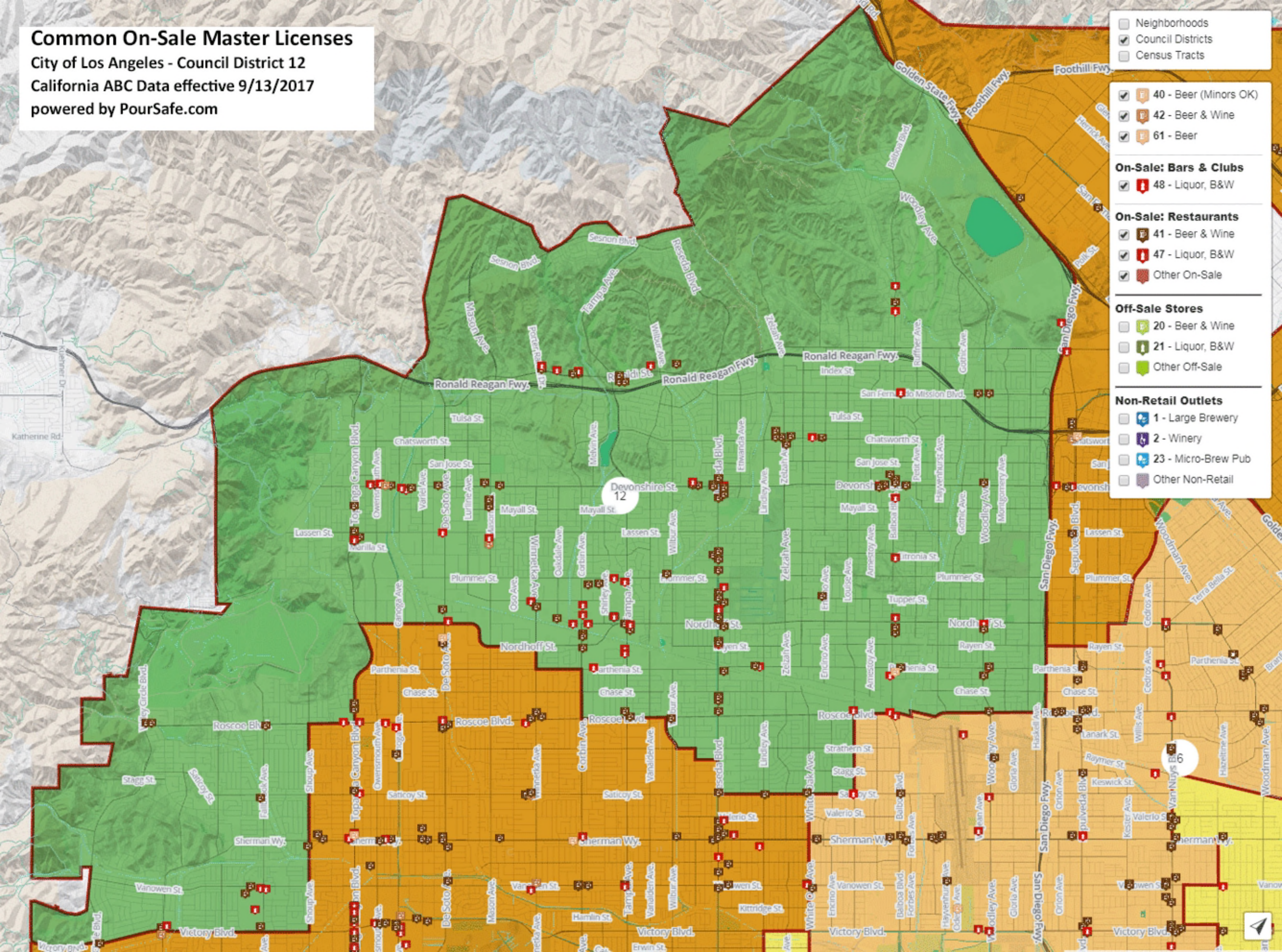

Current Master On-Sale Licenses & Applications City of Los Angeles by Council District



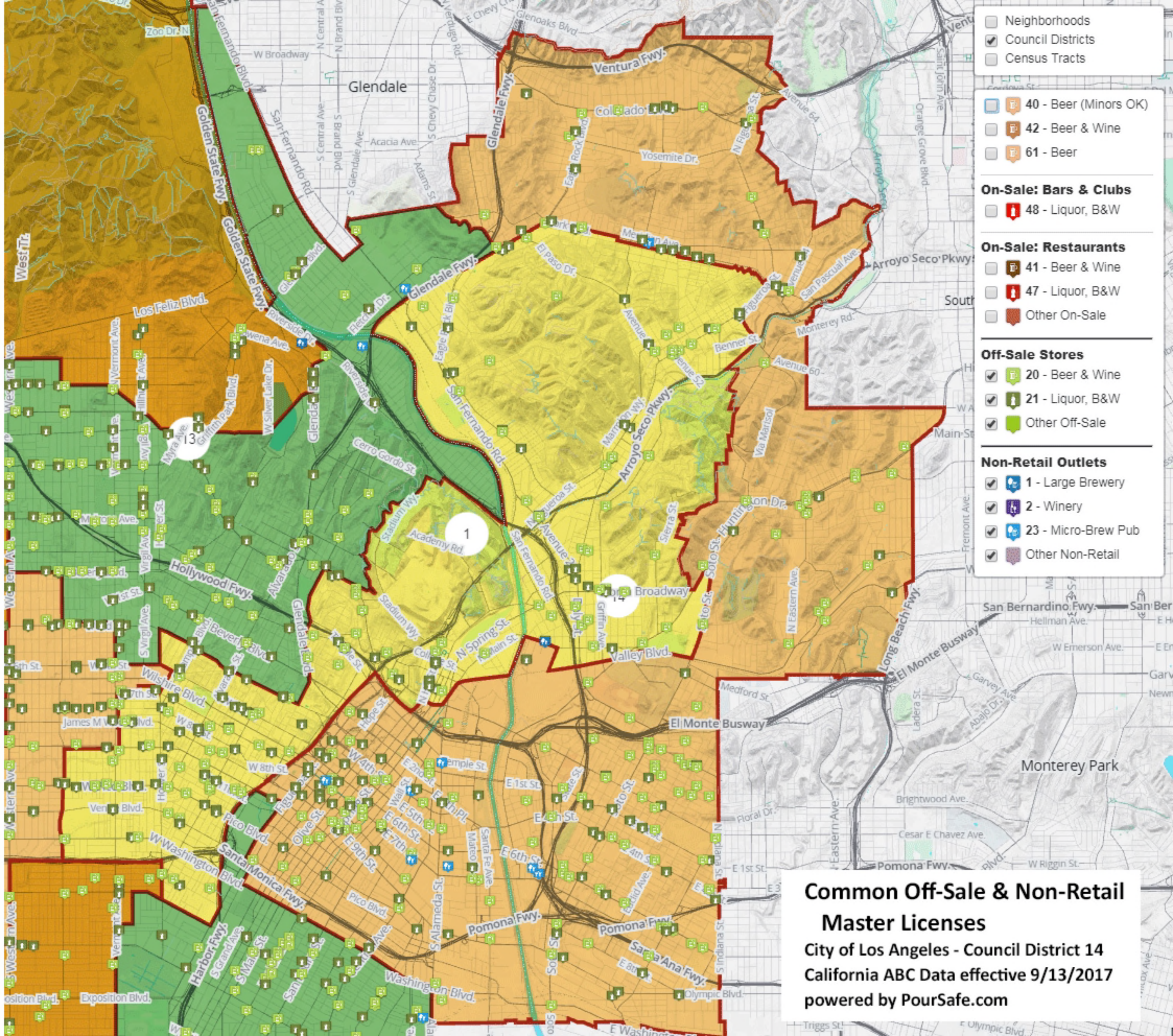

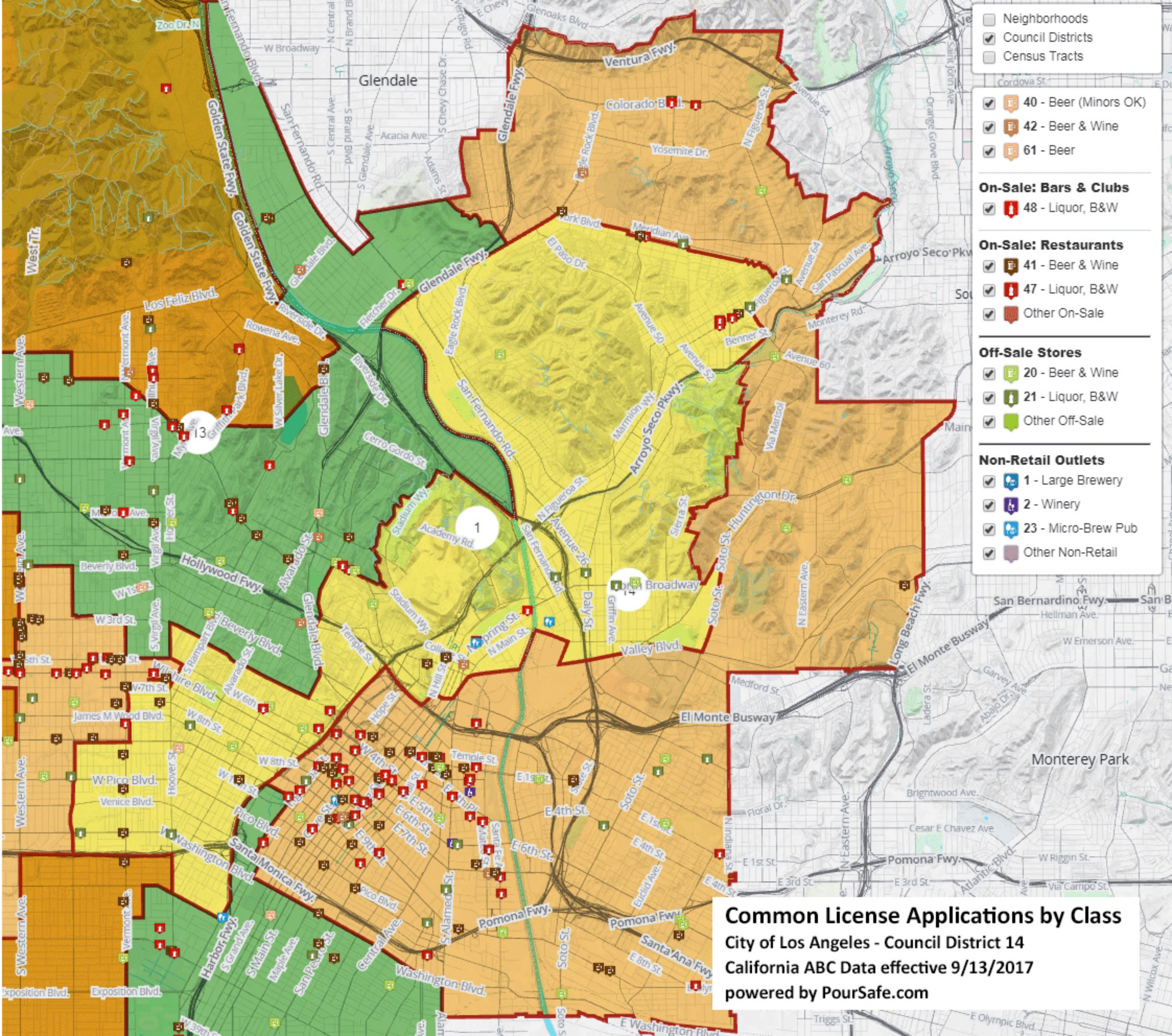
