PROTEST

May 22, 2016

To Whom It May Concern:

My name is Nancy Wolf, and I reside at 1242 Angelo Drive along with my family. It has just come to my attention that it was stated that no one had concerns about the haul route or construction of the house at 1240 Angelo Drive. I am shocked to hear that given the times my family has appeared in court on this very matter. In addition, photos have been supplied showing the blockage to our driveway when the trucks are stuck. We were also visited by someone from the city council's office to see the proximity of the construction to our home. For clarification I will reiterate the issues.

I have lived here during other periods of construction. My house is situated at a hairpin turn on Angelo Drive. During previous projects both my children and I, who are all asthmatic, suffered greatly from the dust and dirt generated by the soil removal process and the offending fumes from the large vehicles carrying materials up and down the roads. There were also multiple times that the trucks were simply broken down at the hairpin turn preventing us from leaving the premises – something which is an obvious danger were someone to have a medical emergency. My husband is 82 years old. One of my sons has anaphylactic reactions to allergic triggers and could need immediate evacuation to a hospital. If he or my husband or anyone else suffered serious medical consequences from not being able to leave the house in an emergency the legal ramifications should be obvious. In addition, in the past the roads have been so badly torn apart that I myself tripped in a pot hole while getting the mail and broke three ribs.

It is also of concern that many small children visit here, which means that young kids may run across the street. Obviously, while efforts are made to prevent such disasters, it is not hard to imagine an out of control hauler careening down the road unable to stop for a five-year-old boy.

Parking is already very limited. When the road is further taken up by builders and their crews, there is simply no place for anyone to park. On multiple occasions we have come out to find cars parked in our driveway blocking the gates from opening. Cars belonging to my family as well as the families of visitors have repeatedly ended up with flat tires due to nails and other sharp objects fallen from construction vehicles. Aside from parking issues, on multiple occasions the trucks have actually crashed into our retaining walls going down the roads, and in some cases

they have run into our own cars parked on the street. We have had to go to the work sites to find the offending drivers, as they of course did not stop to report their accidents.

The noise is another issue. Aside from the clamor made by continuous construction, the noise can be likened to living on Broadway and 42nd street in NYC. We did live there so know that what we are saying is accurate. The haulers and bulldozers grinding up and down the streets in addition to the workers guiding them directly in front of my house is numbing. There are also the special sounds produced when the cement trucks slip and drop pounds of loose gravel onto the streets only to make the road even more undriveable. The city does not fix the streets even after inspecting them probably because the councilmen know in a week the same condition will be back.

The project outlined for 1250 Angelo Drive promises to be logarithmically worse than anything up until now. It is my recommendation that this endeavor ceases before something catastrophic occurs.
