You are hereby notified that the Los Angeles City Council will hold a public hearing on **Wednesday, December 13, 2017** at approximately **10:00 AM** or soon thereafter in the **John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012** (public entrance on Main Street), to consider the following: Negative Declaration, Exemption pursuant to California Environmental Quality Act (CEQA) Guidelines Sections 15378(b)(4) and 15061(b)(3), and related CEQA findings, reports from the Los Angeles City Planning Commission and the City Attorney, Resolution, and draft Ordinances relative to adding Section 19.18 to the Los Angeles Municipal Code (LAMC) and amending Section 16.02 of the LAMC to establish an Affordable Housing Linkage Fee (AHLF), and adding Section 5.582 to Chapter 176 to the Los Angeles Administrative Code to create the Housing Impact Trust Fund for the receipt and use of AHLF monies.


