

I MOVE that the Council Action of March 27, 2018 relative to the transfer of Council District Ten Public Benefits funds for the rehabilitation of the Tom Bradley Youth and Family Center (CF 17-0355), BE AMENDED to adopt the following instructions in lieu of the instructions in the Action of March 27, 2018: TRANSFER / APPROPRIATE \$30,628.02 from the AB 1290 Fund 53P-28, Account No. 281210 (CD10 Redevelopment Projects - Services) as follows: \$5,628.02 to the Water and Power Fund No. 704-98, revenue source code 5166 to pay for an outstanding utility bill [Account No. 257 171 0000], AND \$25,000 to the General Services Fund No. 100-40 as follows: \$10,000 to Account No. 001014 (Construction Salaries) and \$15,000 to Account No. 003180 (Construction Materials, Supplies & Services), for additional rehabilitation / construction activities required at the Tom Bradley Youth and Family Center in Council District Ten.
