

ORDINANCE NO. \_\_\_\_\_

An ordinance adding Sections 63.133, 63.134, 63.135 and 63.136 to Article 3, Chapter VI of the Los Angeles Municipal Code to protect and maintain City property.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. A new Section 63.133 is added to Article 3, Chapter VI of the Los Angeles Municipal Code to read as follows:

**SEC. 63.133. CITY PROPERTY – PROHIBITED ITEMS.**

Without prior permission from the City, no person shall enter a City facility with any of the following:

- A. Any weapon prohibited by Section 171b(a) of the California Penal Code, as amended from time to time, or any successor statute;
- B. Animal (except a service animal);
- C. Alcohol or illegal narcotic or controlled substance;
- D. Aerosol spray, tear gas, mace or pepper spray;
- E. Bat, baton, stick or pole in excess of 12 inches when fully extended;
- F. Box cutter; utility knife or razor blade;
- G. Ice pick, safety pin or tined instrument longer than 2 inches;
- H. Knitting or crochet needle;
- I. Firearm or replica firearm;
- J. Fireworks;
- K. Flammable liquid or spray;
- L. Flashlight longer than 3 inches;
- M. Hand tool or folding multi-purpose utility tool;
- N. Knife of any length;
- O. Laser pointer;
- P. Martial arts weapon of any kind;
- Q. Rock or stone larger than 2 inches in diameter;
- R. Metal, composite or wooden knuckles;
- S. Metal hair pick longer than 2 inches;
- T. Scissors;
- U. Shopping cart;
- V. Sword, saber or other bladed device;
- W. Wheelchair or stroller not used in transportation of a person (all wheeled conveyances are subject to search prior to entry into the building);
- X. Taser or stun gun; or

- Y. Any instrument that expels a metal projectile, such as a BB or pellet, through the force of air pressure or spring action, or any spot marker gun or paint gun.

Sec. 2. A new Section 63.134 is added to Article 3, Chapter VI of the Los Angeles Municipal Code to read as follows:

**SEC. 63.134. CITY PROPERTY – TRESPASS ON.**

(a) No person shall enter the grounds of any property or building used, operated or occupied by the City of Los Angeles under the control and management of the Department of General Services or remain on those grounds or property or in the building in violation of posted rules regarding use, access and presence on such property. Conduct in violation of posted rules shall constitute a trespass.

(b) The General Manager of the Department of General Services shall recommend to the City's Municipal Facilities Committee and the City's Municipal Facilities Committee shall promulgate rules and cause appropriate signs to be posted giving notice of rules applicable to entry and use of City buildings under the control and management of the Department of General Services.

Sec. 3. A new Section 63.135 is added to Article 3, Chapter VI of the Los Angeles Municipal Code to read as follows:

**SEC. 63.135. LIBRARIES – TRESPASS ON.**

(a) No person shall enter the grounds of any property or building used, operated or occupied by the City of Los Angeles under the control and management of the Library Department or remain on those grounds or property or in the building in violation of posted rules regarding use, access and presence on such property. Conduct in violation of posted rules shall constitute a trespass.

(b) The Board of Library Commissioners shall promulgate rules and cause appropriate signs to be posted giving notice of these rules.

Sec. 4. A new Section 63.136 is added to Article 3, Chapter VI of the Los Angeles Municipal Code to read as follows:

**SEC. 63.136. RECREATION AND PARKS PROPERTY – TRESPASS ON.**

(a) No person shall enter the grounds of any property or building used, operated or occupied by the City of Los Angeles under the control and management of the Department of Recreation and Parks or remain on those grounds or property or in the building in violation of posted rules regarding use, access and presence on such property. Conduct in violation of posted rules shall constitute a trespass.

(b) The Board of Recreation and Park Commissioners shall promulgate rules and cause appropriate signs to be posted giving notice of these rules.

Sec. 5. **URGENCY CLAUSE.** The City Council finds and declares that this ordinance is required for the immediate protection of public peace, health and safety for the following reason: In order for the City of Los Angeles to protect city officials, employees and the public by deterring illegal, dangerous, injurious or destructive activities on City property, the amendments to the Los Angeles Municipal Code, as reflected in this ordinance, must become effective as soon as possible. For all these reasons, the ordinance shall become effective upon publication pursuant to Los Angeles Charter Section 253.

Sec. 6. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
