Dear Councilmember Price,

I am writing on behalf of **Community Development Technologies Center**. The issue of neighborhood drilling is of special concern to our organization. For the past 20 years we have been working toward environmental justice and equity; there is concrete evidence that neighborhood drilling is harmful to the neighborhoods we serve in Council District 9.

We respectfully express our support for an ordinance to establish a 2,500-foot setback separating oil and gas extraction operations from sensitive land uses like homes, schools and hospitals. We would also like to express support for the motion introduced on April 19, 2017 (Council File # 17-0447) directing the City Attorney, Petroleum Administrator and Department of Planning to perform a legal and land use study of such an ordinance.

Los Angeles is the largest and most densely populated urban oil field in the nation. The City of LA hosts more than 900 active oil wells, with over 77% located within 2,500 feet of a home or sensitive land use such as a school, park or hospital. More than half of the active wells are located in low-income Latino and African-American neighborhoods already overburdened by environmental hazards, such as Wilmington and South L.A. Residents from these neighborhoods have documented serious health problems—including

nosebleeds, chronic migraines, nausea, asthma and other respiratory illness—in addition to daily disruption from drilling noise and vibrations, foul odors, and diesel truck traffic.

Oil drilling operations are wholly incompatible with residential neighborhoods, and we urge the Council to act swiftly to pass the motion for a legal and land use study, as an important step toward alleviating the harm that front-line communities experience daily. Every Angeleno deserves to live in a safe, healthy neighborhood.

Thank you for your attention and action on matters that directly impact the health and safety of residents living near oil drilling operations. Please contact us if you have any questions or would like additional information.
