Through the LA Zoo's breeding program, Billy has been forced to endure a highly invasive procedure to collect his semen for the purpose of artificially inseminating females at other zoos for breeding. Dear Mr. Koretz,

First and foremost I would like to thank you for introducing the motion to free Billy the Bull Elephant to an appropriate sanctuary from the LA Zoo. Also, thanks to Mr.O'Farrell for seconding the motion.

Using my website as well as social media to promote Billy's cause. I had received an email thanking me for my posts and a confirmation of the sender having signed the petition with the following message (and I quote): "We saw him this weekend while visiting the zoo... it's horrible."

From experience, i know that watching Billy is heartbreaking!

I have spent time, a little money and a lot of heartache over the elephant situation at the L.A. Zoo. It seems there are numerous websites all for the FREE BILLY cause. I have posted links to sign petitions to my FB pages. My hope is to get people involved and help to make the public aware of what is "not so cool at the LA Zoo." I do know that additional signatures on petitions to FREE BILLY were obtained through my efforts and felt good that i was able to make a difference, no matter how small. I am not a letter writer but wrote to Mayor Garcetti in the hope that he would meet with The Elephant Guardians.

You see I care deeply but was somewhat confused after my experience at one of the L.A. Zoo Master Plan Community Meetings. Upon receiving an email to inform me of the meeting, I ordered myself a ticket online to reserve a seat.

Once the meeting was over I walked out, alone, into the damp and chilled night, toward my car, tears streaming for the elephants i left behind the gates to the L.A.Zoo.





According to zoo documents, Billy underwent "training" for the actual semen collection process at least 55 times between January 20, 2011 and November 14, 2014.

This procedure is inhumane and invasive. While this has been touted as a practice of "conservation," the data shows that it is nothing of the sort, with elephants in zoos dying in captivity faster than they can reproduce due to the unnaturally high mortality rates of elephants in captivity. The only real way conservation for elephants can occur is in the wild and a certified elephant sanctuary is the closest thing to a natural environment that we can give to Billy.

There is no science- or conservation-based justification for the LA Zoo to keep Billy or ANY of the elephants, including females Tina and Jewel - in captivity. The scientifically validated negative effects of captivity on elephants are irrefutable and well documented.

Los Angeles must seize this opportunity for leadership on humane animal welfare issues and policy. Therefore, we urge you to support the relocation of Billy to a GFAS-certified sanctuary to transfer elephants Tina and Jewel as well - end all elephant captivity and elephant breeding programs at the LA Zoo immediately.
