Thank you for hearing our public comment yesterday regarding Billy the Elephant who has been held at the LA Zoo for almost 30 years. I urge this committee to move forward with the appointment of the independent medical panel and the physical and psychological health assessments of Billy. The public is very concerned about his health and well-being.

I have the following questions/requests and would appreciate a response:

- 1. When will the names of the medical panel be released to the public? The members of the panel must be made public prior to the assessments to ensure that there is no bias in this process.
- 2. What is the timeline for the appointment of the panel and the completion of their reports?
- 3. At least 2 advocates for Billy's release to sanctuary must be included in the medical assessment process. As it stands now, the zoo employees (who are also the advocates for keeping Billy in the zoo) will have unlimited access to the members of the medical panel which is inherently biased. The process must be monitored by advocates for Billy's release.

As I said at the committee meeting, Councilmember Ryu, and any other Councilmembers who would like to accompany him, have an open invitation to visit the Performing Animal Welfare Society (PAWS) to view the 15-acre environment you can provide for Billy. You do not have to wait for anyone to propose dates. You are welcome to visit at your convenience. Please let me know if you need any assistance in scheduling your visit.
