Decisions about the health and welfare of Billy the Elephant and other zoo animals should be made by professionals, not celebrities or politicians, however well-meaning they may be.

Caring for any animals in captivity is complex and not amenable to soundbites and simplistic prescriptions. The LA Zoo has Billy housed in a high-quality facility that is suited for his needs. He is attended by a caring, professional staff. No legitimate welfare concerns have been raised. This is a misguided attempt to prioritize what a handful of people think is best for this animal over what scientific research has shown to be best for the animal.
