Therefore, your actions will have a negative impact on wildlife rehabilitation efforts, and the recovery programs it supports. Research the effects of this motion, because if you vote to move Billy away from his home of 33 years, you vote to put a gunshot in one of the largest conservation programs in the world. Is *that* the trophy you're looking for?

Could we thrive and succeed into getting into college? So, we can expand our chances of success in our adult lives. Every morning that I walked to school, I would have a backpack full of supplies, from notebooks, to pencils and even a calculator. But, to my disappointment the majority of those items were rarely used. I was shuffled from each class only to be "babysat" by a substitute teacher. They would send us home with textbooks, assign homework, and when we returned to class the homework was never collected. But, when it came to doing the standardized testing, we were told to do our best and the reality was that we were never taught the material that we were being tested on. The scores were low and at the end of the day it was our fault. The school would label its students as having behavioral problems and therefore our education

was not a priority. Therefore, the system goes unchecked because the people who can make these decisions do not continue further into the process to ensure that things are being done correctly. So, how does this relate to Billy the Elephant? In many ways it does, are the decisions being made, for his needs, just feelings or for the glory of "finally" winning this battle?

The moment I found my inspiration to conserve wildlife, that was the driving force that I used to push myself to graduate from the LAUSD schooling system, to go on to get my Associate of Art degree in Liberal Arts; attend a four-year university and accomplished getting my Bachelors of Science degree in Environmental Biology. The journey itself was not that easy. The learning skills that I needed to obtain from elementary, middle and high school were minute. So, while I would understand the material taught at the college-level I would have to work extra hard than the other students, which made learning a struggle and left me disappointed. But, I still managed to make my education a priority because it is important to me. In order to get to school, I would use public transportation via the buses and trains and take a three-hour bus ride to school and take a three-hour bus ride back home. In the six hours of travel that I put in, I would study on the bus and try to give myself the best advantage as a student. But, I did not complain because in my mind, I was taking back what I lost out on in my "childhood education."

For all the students that got lost in this schooling system you might wonder where they ended up and how much did they fight to thrive in Los Angeles? For me, my journey took me to the Los Angeles Zoo and Botanical Gardens where I started out as a General Volunteer in 2005. The moment that I walked into the zoo, I could feel a change in my future outcome mainly because of the people that worked there. On my first day, I was surprised and taken aback by the friendly greetings and the way they got everyone involved in the zoo process and the number of people that asked me "how am I doing?" That one simple question made up for the lifetime of people who never really cared enough to ask me. It may seem odd, but that was just the reality of growing up in Los Angeles. In 2007, I got my first employment opportunity as a Camp Counselor and it was this moment that I realized that I was in a good place and the window of opportunities would be endless for me. I started out as a "shy/quiet person" at first but from this time I thrived and developed more than I did as a child. I am now working at the zoo as an Education Specialist, where I get a chance to do public speaking, lead tours, do animal presentations, interact with the public and help run children classes. Therefore, in a zoo setting there is growth, potential to thrive, succeed and there exist a safe place for physical, mental and emotional development. For a human being, such as myself, I came from a place in Los Angeles that limited my prospects in life and went to a zoo in Los Angeles that expanded the horizons of opportunities available for me.

For the animal residents of the zoo, they will probably feel the same way that I do. There is an old saying of how we shouldn't implore human feelings onto animals, but for many animals they can sense when they're in good hands. Billy the Elephant does have a story to tell just like me. He came from an unknown world and ended up at the Los Angeles Zoo. Here he gets greeted by the same welcoming people that I meet on my first day at the zoo. His ability to thrive in a zoo setting comes in the form of enrichment, his bonding with his handlers, and the positive environment that they work with him in. How can you tell? What can we use to measure it? We can time out of our busy schedule to visit Billy at the zoo and see how he interacts with his keepers, walk around his entire exhibit and glance at him from afar and watch him and learn about his personality on different days and at different hours. Here Billy is an individual, here he has a team of keepers that lookout for him; in addition, to the 300 plus employees of the zoo. In an alternate perspective, we can ask ourselves about sanctuaries, which can give Billy one thing; space.

One visit to the Los Angeles Zoo, changed the outcome for 1 of 118,000 students that visited each year. One elephant of many is changing the conversation about wildlife. Billy, is one of the many residents of the City of Los Angeles, and his care at the Los Angeles Zoo is a reflection of the many Angelinos that want things to "matter."

The Elephants of Asia habitat at the Los Angeles Zoo is Billy's home. In fact, it's the only home that he has ever known. Billy lives in one of the best and largest elephant habitats in North America and benefits from tremendous resources, a dedicated staff, and top-quality health care. Elephants of Asia is the largest habitat at the L.A. Zoo and the space vastly exceeds the standards of the Association of Zoos and Aquariums (AZA), as well as those of the U.S. Department of Agriculture and the California Department of Fish & Wildlife.

Billy's quality of care at the L.A. Zoo far surpasses that which he would receive at any sanctuary. Elephants are highly intelligent and sociable animals, and they form deep emotional bonds with their caregivers and other elephants. Billy's caregivers have known him for decades and he receives the best care possible at the L.A. Zoo.
