To Whom it May Concern,

I am a resident of Los Angeles County, an animal rights activist. I am writing today in regard to Los Angeles City Council motion #17-0453.

Please reconsider and do not send Billy to a sanctuary. The Los Angeles zoo is an AZA accredited facility, which means that they adhere to higher guidelines in regard to health, medical treatment, enrichment, and enclosure than any sanctuary is legally obligated to do.

The sanctuary that they are proposing to send Billy to is a problematic one, and has had cases of diseases such as tuberculosis in the past in the elephants they have cared for. They do not have the knowledge or training in their staff to provide for this elephants well-being in the event of infection. The zoo's standards for their elephant enclosure exceed that of the basic standards set forth by the AZA, and they have the financial stability to ensure proper care is given to their elephants.

There is also the matter of this elephant being isolated from the rest of his herd. If he were to go to a sanctuary, Billy is a bull elephant. As a male, he would have to be separated from any females to prevent breeding. The zoo has their own measures to prevent this so that he is allowed to remain in the enclosure with Jewel and Tina (the two female elephants). He would also be further isolated by breaking the bonds he has formed with his keepers and caregivers, Elephant behavior is very complicated compared to a vast majority of herd animals, and they have levels of intelligence that exceed that of even some primates (according to a a series of tests conducted through the department of psychology at St. Andrew University, UK). They form bonds with other elephants, and with those people who work alongside them. They are emotionally intelligent animals and should be treated as such. The level of care and enrichment at the zoo means that these elephants are provided for in a way that no sanctuary would be able to match.

There is yet another matter of sanctuaries not being concerned about conservation. Some animal rights activists fail to understand how AZA accredited institutions work, especially those focusing on the conservation of species, The Los Angeles zoo has an immensely good conservation and ambassadorship program, I urge you to research it thoroughly. An organization focused on the conservation and protection of endangered and threatened species will ultimately be far more concerned with their overall welfare than an ill-informed and so-called "sanctuary". Most of these "sanctuary" facilities do not employ educated or professionally trained staff, which can lead to misconceptions about animal behavior and treatment, as well as anthropomorphization of their actions. Projecting ideas of human emotions on animals, such as statements of "It looks sad" in regard to an animal who does not and cannot emote or even express emotion in a way comparable to that of a human, does a disservice to education and public understanding of animal behavior.

In conclusion, I strongly oppose sending Billy to a sub-par facility that will not be able to care for this elephant or his

best interests. Please collect information on animal behavior from REPUTABLE scientific studies and sources, and review the AZA guidelines. Send someone to physically view and document his enclosure, and I am certain you will find that this elephant is in beyond capable hands in the care of teh Los Angeles zoo.
