I understand another couple of large tree limbs fell while I was out of town and one damaged the roof of a car. I expect you may have already gotten the insurance claim. FYI the limb that damaged the car was not from a tree that the city had marked for removal. The insurance claims from tree damage will soon be more than the cost of tree removal. I don't understand the city's willingness to pay insurance claims, but not prevent damage, which could one day be catastrophic.

I understand a neighborhood watch meeting has been set for next month, although I haven't received any official notice as of yet. Please let me know if there is anything I can do to get the word out.

So I spoke with the arborist at Urban Forestry about the trees on your street. He confirmed the arrows are for utilities, in case the trees are removed.

However, he said all of them are currently backlogged for removal. He could not give me an estimate on when they will be removed. He did, however, let me know which ones are dead: 7044, 7056, 7106, 7112, 7113, and 7118.

The Mayor will be releasing his budget proposal for the next fiscal year near the end of April, as soon as I hear what has been allotted for tree removal I will let you know.
