I'm writing as the President of Friends of King, a parent organization which supports the academic and enrichment of close to 2,000 middle schoolers aged 11-13yrs old at LAUSD's Thomas Starr King Middle School. Hundreds walk to school each day, unaccompanied. Hundreds more would, were the streets safer. Our school is located at 4201 Fountain Avenue, in CD4, along the High Injury Network.
