MOTION

In January 2017, as the result of a water service leak near 13319 Mulholland Drive within Council District 4, the slope adjacent to the street experienced rapid mass erosion. The repair of the slope is critical to the integrity of the roadway in this hillside area.

The Los Angeles Bureau of Engineering (BOE) is providing assistance to the Los Angeles Department of Water and Power (LADWP) to address this problem, including: damage assessment, engineering design, and construction, using BOE's contractor for the current work on the Mulholland Drive (13319) Bulkhead project.

Action is needed to approve a transfer of funds totaling \$304,000 from LADWP to BOE to fully reimburse City staff costs directly associated with the water service leak, as well as the total cost for the related slope repair. Sufficient LADWP funds are available for this project.

I THEREFORE MOVE that the Bureau of Engineering (BOE) be authorized to receive/accept \$304,000 from the Department of Water and Power (DWP), and deposit such funds into the Special Gas Tax Improvement Fund No. 206, Department No. 50 (206/50) and appropriate therein to a new account entitled, Mulholland Drive (13319) Bulkhead – LADWP Change Order; any funds remaining in the Mulholland Drive (13319) Bulkhead – LADWP Change Order account after the completion of the project shall be reimbursed to LADWP.

I FURTHER MOVE that BOE be authorized to make any corrections, clarifications, or revisions to the above fund transfer instructions, including any new instructions in order to effectuate the intent of this Motion, and any corrections and changes to fund or account numbers; said corrections/clarifications/changes may be made orally, electronically, or by any other means.
