NOTICE OF PUBLIC HEARING

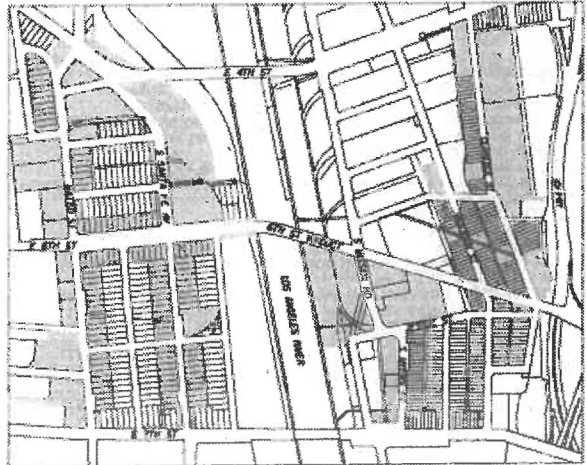
