As a Cadet with the city police department, I was assigned various duties which included evidence collection and inventory; jailer; dispatching calls to officers; writing crime reports; and crime scene photography and other duties.

1973 – 1993 ATT/Pacific Telephone

Assignments and positions included maintenance of nationwide long distance network for major national corporations; manager in consumer relations and government relations; corporate liaison to national Latino community organizations; and account executive/technical support manager in local marketing group.

1993 – 1995 Catholic Charities

Regional Director for a Los Angeles county based at risk youth program called Hope In Youth. Managed and supervised 12 teams of three community workers assigned to provide family resource support, youth mentoring and school reintegration support for assigned youth.

1995 – 1998 Orange County Human Relations Council

Under the non-profit arm of the Orange County Human Relations Commission, assignments included gathering and analysis of data for annual hate crime report; police and community relations liaison; and mediation specialist.

1998 – 1999 Los Angeles County Community Development Commission

Assistant Director for a community resource center located in the unincorporated area of Whittier CA. Assignments included supervision of daily activities of resource center; assessing needs of local community and researching feasibility of acquiring resources to meet those needs, scheduling community outreach events and activities; and other assigned duties.

As Project Supervisor for the Human Relations Commission Branch of CSS, I manage the programmatic outcomes for twelve contract agencies that provide community based conflict resolution resources through our Countywide Dispute Resolution Program. Also, my Commission assignments have included project management for a federally funded gang violence reduction project in the harbor area of Los Angeles; participation in countywide gang violence reduction strategy; coordinator of faith based efforts for the commission; past project coordinator for the Hate Crime Victim Assistance and Advocacy Initiative where eight community based non-profit agencies provided direct hate crime victim assistance and education regarding hate and bias related criminal activity and advocacy for their respective communities. Additionally, current assignments include liaison to the Los Angeles Police Department's Community Relations Unit attached to Chief Beck's office where police/community relations strategies are developed and implemented to minimize police and community misconduct during major demonstrations and protest marches; development of a new Constituent Response strategy to address public action requests and concerns regarding intergroup relations issues within the county and finally, development and implementation of the commission's countywide Police/Community Relations Initiative.


