

ORDINANCE NO. 186030

An ordinance amending Section 57.202 of the Los Angeles Municipal Code regarding the definition of "Requested Inspection."

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. Section 57.202 of Article 7, Chapter V of the Los Angeles Municipal Code is amended to insert the following definition in alphabetical order to read as follows:


**Requested Inspection.** An inspection that is requested by a business or building owner with the intent of receiving a Fire Clearance Letter stating that the building and business are Fire Code compliant at the time of the inspection. Normal periodic inspections and inspections covered under other sections of the Fire Code do not constitute a Requested Inspection under this definition.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
