The proposed licensee attached permanent, lighted signs to the building on April 15, 2017 soliciting/advertising both "Wine & Spirits" and prominently displayed the premises as the 'Home of Beer Pong". It also constructed a 15-20 foot high "Liquor" sign on a stand alone post in the adjacent parking lot. (See attached photographs) The availability of liquor and game amusements at the proposed location adjacent to the public sidewalk and in the same shopping center with the bar, The Fifth, (located at 4821 Whitsett Ave.), causes a confluence of facilities that will likely expose children, teenagers and minor, pre-adults to the public consumption of alcohol and associated crime related problems; The proposed location will also likely offer many items that would appeal to children, including "pong" and displays/ racks that are visible from outside through large glass widows covering the entire front of the proposed store. The alcoholic beverage items would apparently be offered for sale throughout the premises and near the cash register and exit that is in close proximity to items that attract or entice children.
- 3. Issuing an additional license in this area would not serve public convenience or necessity under Bus. & Prof. Code, §§ 23958, 23958.4, subd. (b)(2) and the proposed applicant did not post a 30-day notice of sale of alcoholic beverages until the Department was notified on or about May 31, 2017 that said notice had not been posted.
- 4. The proposed location is within the immediate vicinity of Temple Beth Hillel/school (approx. 1/10 mile, a facility that already filed a protest based primarily on the ground that issuance of a license to the proposed location would result in/add to an undue concentration of licensed premises: it does not serve public convenience or necessity..
- 5. The proposed location is also located within 100 feet and within a residential area and the proposed applicant has not established that the normal operation of a licensed premises would not interfere with the quiet enjoyment of their property by the residents of the area. The proposed applicant has also not established that sale of alcoholic beverages would not attract vagrants and people loitering or that operations would not tend to create or exacerbate already existing law enforcement problems. These problems include increased crime as described in the protests already filed with the Department of Alcoholic Beverage Control for the proposed license number 581516. I have also observed people publicly consuming alcohol and walking on the street who appeared to be intoxicated or under the influence due to the large concentration of alcohol sales in the small geographic area. I recently saw graffiti being applied to buildings just behind my store around 100 feet from the proposed premises. It has been my experience that vagrants will stop at one store then another, which just adds to potential conflicts caused by additional customer interaction. It also increases loitering, public drunkenness and urination and other unpleasant and nasty behavior.
