You are hereby notified that the PLUM Committee of the Los Angeles City Council will hold a public hearing on **Tuesday, October 31, 2017** at approximately **2:30 PM** or soon thereafter in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012 (entrance on Main Street), to consider the following: Mitigated Negative Declaration (MND), Mitigation Measures, Mitigation Monitoring Program, Errata, and related California Environmental Quality Act findings, report from the Los Angeles City Planning Commission (LACPC), and an appeal filed by Arts District Community Council and Yuval Bar-Zemer (Representative: John Given, Law Office of John Given) from the determination of the LACPC in approving the MND No. ENV-2013-2994-MND, and sustaining the determination of the Advisory Agency's approval of Vesting Tentative Tract Map No. VTT-74112-1A for the merger of two lots and resubdivision into one master ground lot and 13 airspace lots for a maximum of 344 live-work units and 29,544 square feet of commercial space, for the property located at 1525 East Industrial Street, 1549 East Industrial Street and 656-660 South Alameda Street, subject to modified Conditions of Approval.

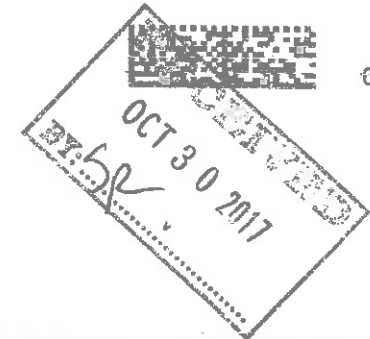
