Mr. Goulds and his art gallery are now working with the City and faithfully following the process the City outlined years ago to modify the use of the building for future planning. L.A. Mr. Goulds and the gallery are faithfully following the process the city outlined years ago to modify the use of the building for future planning. L.A. Louver has held several community meetings, obtained the support of both the Venice Neighborhood Council and West Los Angeles Area Planning Commission, and has

gathered over 200 letters of support from the immediate neighborhood and wider community.
