**PROPOSED GENERAL PLAN AMENDMENTS FOR THE SAN PEDRO COMMUNITY PLAN
AREA; CPC-2009-1557-CPU; CPC-2009-1557-M1; CPC-2009-1557-M2**

Pursuant to the provisions of Section 551, 555 and 558 of the City Charter, transmitted herewith is the March 14, 2013, October 13, 2016, and August 10, 2017 actions of the City Planning Commission approving the proposed General Plan amendments to the San Pedro Community Plan and Circulation Element (Mobility Plan 2035).

The proposed General Plan amendments to the San Pedro Community Plan, and related amendments to the Circulation Element, are submitted to you for your recommendation, which is to be forwarded to the City Council as specified by Section 11.5.6 of the Los Angeles Municipal Code.

The City Planning Commission, as evidenced by the attached Findings, has determined that the proposed General Plan amendments, land use designations, and zone changes, including adoption of the new Community Plan Implementation Overlay (CPIO) District will be consistent with the City's General Plan.

Your action is requested on the proposed plan amendments as specified by Section 11.5.6 of the Los Angeles Municipal Code. The zone changes will be transmitted to you following the City Council's action.

RECOMMENDATION

That the Mayor:

2. Recommend that the City Council adopt the attached Findings of the City Planning Commission relative to the General Plan amendments; and
3. Recommend that the City Council adopt, by Resolution, the General Plan amendments to San Pedro Community Plan and Circulation Element, and, as shown in the attached exhibits; and
4. Recommend that the City Council direct staff to revise the San Pedro Community Plan and the Circulation System map of the Circulation Element in accordance with this action.

Pursuant to the provisions of Section 551, 555 and 558 of the City Charter, transmitted herewith is the March 14, 2013, October 13, 2016, and August 10, 2017 actions of the City Planning Commission approving the proposed General Plan amendments to the San Pedro Community Plan and Circulation Element (Mobility Plan 2035). The City Planning Commission also approved the adoption of an Ordinance repealing the existing Downtown San Pedro Community Design Overlay (CDO) District and boundaries, the adoption of the Community Plan Implementation Overlay (CPIO) District, and the requested rezoning actions to effect changes of zone and height districts as set forth in the attached exhibits.

The City Planning Commission, as evidenced by the attached Findings, has determined that the proposed General Plan amendments, land use designations, and zone changes will be consistent with the City's General Plan.

The proposed General Plan amendments were submitted to the Mayor whose recommendation will be forwarded to you as specified in Section 11.5.6 of the Los Angeles Municipal Code.

RECOMMENDATION

3. Adopt, by Resolution, the General Plan amendments to the San Pedro Community Plan and Circulation Element, as set forth in the attached exhibits; and
4. Adopt the Ordinances to effect changes of zone and height district, repeal the San Pedro Community Design Overlay (CDO), and establish the San Pedro Community Plan Implementation Overlay (CPIO) District, as set forth in the attached exhibits; and
5. Direct staff to revise the San Pedro Community Plan, the Circulation System Map of the Circulation Element, and update the appropriate zoning maps in accordance with this action; and
6. Certify and Adopt the Environmental Impact Report ENV-2009-1558-EIR; and
7. Adopt the Statement of Overriding Considerations.
