SOUTH LOS ANGELES COMMUNITY PLAN UPDATE

Council File No.: 17-1054

On December 29, 2019 the update to the South Los Angeles Community Plan, one of 35 Community Plans that comprise the Land Use Element of the General Plan of the City of Los Angeles became effective. A summary of the actions of the community plan update is as follows:

- <u>Certification of EIR.</u> On November 22, 2017, the City Council certified the Final EIR as found in Council File No. 17-1054 (Exhibit G, filed 9/13/17) for the South Los Angeles Community Plan Update in compliance with CEQA and Notices of Determination were filed by the Department of City Planning, as required by the Public Resources Code and CEOA Guidelines.
- <u>General Plan Amendments.</u> On November 22, 2017, the City Council adopted the General Plan text and map amendments as found in Council File No. 17-1054 (Final Exhibit C, filed 11/13/18) to: (a) the South Los Angeles Community Plan (Land Use Element); (b) the General Plan Framework; and (c) the Mobility Plan 2035 (Circulation Element).
- Implementing Ordinances. On December 12, 2018, the City Council adopted the following two implementing ordinances as found in Council File No. 17-1054: (a) the South Los Angeles Community Plan Implementation Overlay District (Final Ordinance No. 185927, filed 12/29/18 and accompanying CPIO District Plan, filed 11/20/18) and (b) the Zone Change and Height District (Final Ordinance No. 185926, filed 12/29/18).
- 4. <u>Effective Date.</u> The General Plan Amendment Resolution Documents (Final Exhibit C) and the two implementing ordinances (Final Ordinance Nos. 185926 and 185927) are effective as of **December 29, 2018**.
