- 2. AUTHORIZE the following changes to Motion [attached to C.F. No. 18-0250], dated June 5, 2018, concerning Valerio Gruppioni, et al. v. City of Los Angeles, BC553109:
 - a. Rescind Recommendation No. 4:

INSTRUCT the City Clerk to place on the agenda for the first regular Council meeting on **July 1, 2019**, or shortly thereafter, the following instruction:

AUTHORIZE the Controller to transfer \$4,000,000 from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009796, Recreation and Parks Liability Payouts.

b. Replace with the following:

AUTHORIZE the Controller to transfer \$4,000,000 from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009796, Recreation and Parks Liability Payouts, in FY 2018-19.

c. Amend Recommendation No. 3(b) of the Motion dated June 5, 2018 as follows:

AUTHORIZE the City Attorney to draw a demand from Fund No. 100/59, Account No. 009796, Recreation and Parks Liability Payouts, made payable as follows:

\$4,000,000 made payable to Bentley and More LLP Attorney Client Trust Account, and Shernoff Bidart Echeverria, LLP, a lien holder, in FY 2018-19.
