Dear Council Member Bonin:

Please be advised that at a regular public meeting of the Venice Neighborhood Council (VNC) Board of Officers held on December 19, 2017, the following Motion was approved.

MOTION:

Whereas - placing portable public bathrooms of any kind in proximity to residences or businesses will place undue burden on property owners,

Therefore, the VNC recommends any portable bathrooms or sanitation stations be open 24/7 and placed exclusively on city owned property and not within 50 feet of the entrance to any residence or business and be manned by at least one attendant at all times with daily maintenance.

Furthermore, the VNC recommends AGAINST placing mobile public bathrooms or sanitation stations on sidewalks or streets adjacent to any private property (residential, commercial, or industrial) without prior written consent of property owner(s) AND 2/3 of property owners on both sides of the contiguous city block with exceptions for special events and construction sites.
