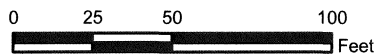
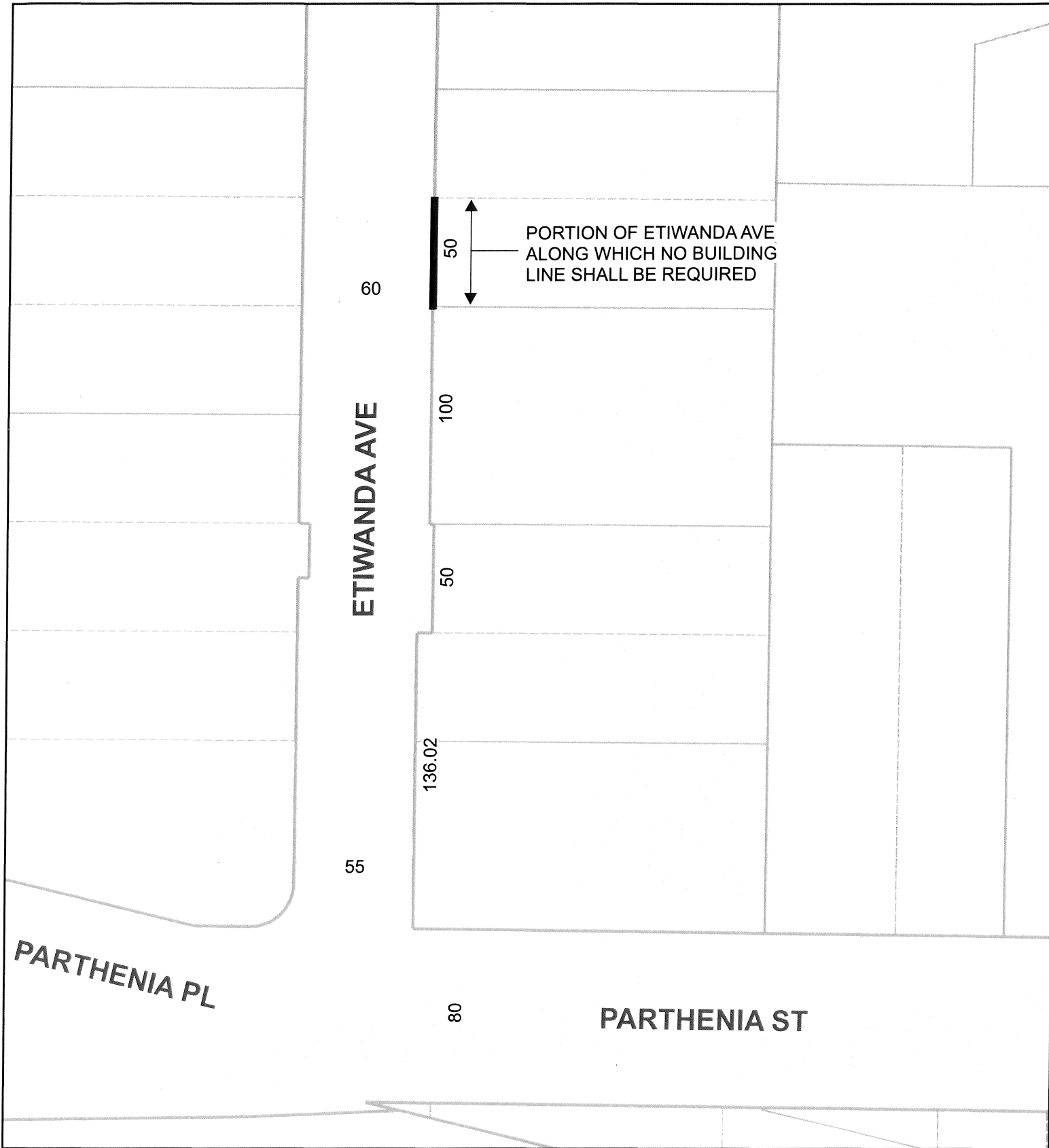
An ordinance amending the following ordinance establishing building line Ordinance No. 102,141

**THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:**

**Section 1.** The following Ordinance ordering the establishment of building line pursuant to the diagram in Section 2 is amended by repealing that provision which ordered its establishment:

Ordinance No. 129,661 (A building line on the east side of Etiwanda Avenue between lines 186 ft. and 686 ft. north of Parthenia Street)

**Section 2.** The following diagram displays the building lines listed for removal in Section 1 of this Ordinance:

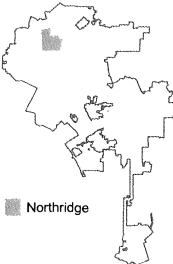

XX.** The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

Pursuant to Section 558 of the City Charter, the City Planning Commission on 09-07-2017 recommends this ordinance **BE ADOPTED** by the City Council.





## DECLARATION OF POSTING ORDINANCE
