RE: COUNCIL FILE TRANSMITTAL

On November 14, 2017, the Public Works and Gang Reduction Committee (PWGR) considered City Administrative Officer (CAO) reports and the Energy, Climate Change, and the Environmental Justice Committee's (ECCEJ) October 16, 2018 consideration of a pilot program to employ homeless individuals for the Loose Litter Cleanup Program, Council file No. 17-1121. After consideration, PWGR adopted the following recommendations, subject to the approval of the Mayor:

1. APPROVE the proposed framework for the pilot program as detailed in the CAO report dated May 18, 2018.
2. TRANSFER \$2.95 million from the Unappropriated Balance Fund No. 100/58, Account No. 580272 - Homeless Services Programs to the Bureau of Sanitation (BOS) Contractual Services Account to implement the pilot program.
3. INSTRUCT the BOS to execute and administer a contract with Chrysalis to implement the pilot program.
4. INSTRUCT the BOS to coordinate with other city agencies involved in the pilot program to report back in 12 months from the date of implementation of the pilot program with results and recommendations going forward.
5. INSTRUCT the CAO to provide the Budget and Finance Committee a cost-benefit analysis between the Office of Community Beautification (OCB) and the Bureau of Sanitation (BOS) administering the contract.
6. INSTRUCT the CAO to contact the Coalition of the Los Angeles City Unions to clarify issues regarding the Targeted Local Hire Program.
7. RECEIVE and FILE the CAO report dated May 18, 2018 relative to a pilot program to employ homeless individuals for the Loose Litter Cleanup Program.

This file is now transmitted to the Budget and Finance Committee.
