RE: COUNCIL FILE TRANSMITTAL

On June 27, 2018, the Transportation Committee considered Los Angeles Department of Transportation (LADOT) reports relative to Dockless On-demand Personal Mobility Services including the Dockless On-demand Personal Mobility Rules and Guidelines, Council file No. 17-1125. After consideration, the Committee moved to approve the recommendations as detailed below:

- Receive and File both LADOT reports.
- 2. Adopt Dockless On-demand Mobility Rules and Guidelines, as amended to:
  - a. Add tail light requirement to Safety section "a" (page 4);
  - b. Add California Vehicle Code definition of motorized scooters to Safety section (page 4):
  - c. Amend Safety section "d" (page 4) to require "No Riding On Sidewalks" in minimum 48-point typeface on the platform of every scooter;
  - d. Delete Fleet Size section "e" (page 4);
  - e. Amend Fleet Size section "g" (page 5) to allow up to 3,000 vehicles;
  - f. Amend Fleet Size section "h" (page 5) to allow up to 2,500 additional vehicles in disadvantaged communities; operators may be allowed up to 5,000 additional vehicles in disadvantaged communities in the San Fernando Valley;
  - g. Amend Fleet Size section "i" (page 5) to require the General Manager to publish the criteria used to evaluate expansion permits;
  - h. Add new Fleet Size section "j" (page 5): "The General Manager may reduce the permitted number of vehicles in the case of demonstrated noncompliance and/or nonperformance by permittee.";
  - Delete "Failure to remove vehicles incorrectly parked within 24 hours" in Enforcement & Termination Grounds section "c";
  - Amend Outreach & Equity section "a" (page 10) to add "Disability Rights Organizations/Centers for Independent Living" to list of organizations to be consulted; and,
  - k. Amend Fees section (page 10) to reflect Option 1 of LADOT report.

- 3. Authorize the LADOT to make technical changes to the Rules & Guidelines.
- 4. AUTHORIZE the Controller to establish a new account entitled "Dockless On-demand Mobility Program" within the Permit Parking Program Revenue Fund No. 49C/94; and, Authorize LADOT to:
  - a. Accept payments for permit fees and administrative costs;
  - b. Deposit those payments into a new Revenue Source Code entitled "Mobility Program" within Fund 49C;
  - c. Appropriate those deposited funds to the new account entitled "Dockless Ondemand Mobility Program";
- 5. Instruct the Information Technology Agency to report in 60 days with the steps and cost estimate necessary to integrate reporting of improperly parked or inoperable devices into 311.
- 6. Instruct the LADOT to report in 90 days with an update on the program.
- 7. Instruct the Bureau of Street Services and the Bureau of Sanitation to report in 60 days after implementation on enforcement procedures and staffing needs.
