Esteemed Council Members,

We are submitting this letter with respect to LA DOT's existing dockless mobility pilot that is being reviewed by the committee. CLEVR Mobility is one of the companies that applied to the LA DOT in April 2019, yet did not receive a permit.

We have watched the last several months of deployment with great interest, and have also attended community meetings to hear feedback from stakeholders and residents. Without fail, concerned residents list the lack of compliance with regulations as their primary concern – specifically with the consistent violation of sidewalk riding and parking rules. For several months now, CLEVR has been advocating for the use of better technology to proactively manage deployed vehicles in finite geofenced areas, rather than only relying on user behavior management. Despite other operators' claims that this is not possible, we have recently demonstrated this technological capability to several cities, including LADOT personnel just last week. We extend an open invitation to all council members to test our precise geofencing for themselves right outside of City Hall. The city should refrain from allowing operators to deploy devices with inadequate GPS tracking capabilities and poor ability to manage devices remotely – unenforceable parking, discarded vehicles, and right of way issues are inevitable with that approach.

Furthermore, it is clear that technology and hardware improvements in this arena are moving at a rapid pace. To commit to a 12 month pilot of virtually identical platforms with no opportunity to introduce a truly differentiated technology and vehicle seems counter to the stated goal of this pilot. We believe that periodic reviews of new technology advancements should be considered.

Lastly, we feel that CLEVR was somewhat arbitrarily denied a permit for allegedly not being ready to deploy in a timely manner. As an example, it has been 2 months since permits were issued with the requirement to be deployed within 30 days and Bolt Mobility, awarded a permit for 500 vehicles, has yet to deploy a single unit as of this date. It certainly doesn't seem like equitable treatment of applicants. We would like to request that council consider allowing for the addition of CLEVR Mobility to the ongoing pilot.
