SUBJECT: RESOLUTION NO. 17-8154 - PROPOSED PERMIT NO. 930 WITH THE JANKOVICH COMPANY

Pursuant to Section 606 & 607 of the City Charter, enclosed for your approval is Resolution No. 17-8154 authorizing proposed Permit No. 930 with The Jankovich Company (Jankovich); which was approved at the August 17, 2017 meeting of the Board of Harbor Commissioners. Jankovich currently leases property at Berth 74 to operate a marine fueling station; providing marine fuels and lubricants to small commercial, recreational, and fishing vessels, as well as bunker fueling services to larger vessels. The proposed Permit is for a 20-year term, with two five-year renewal options and will relocate Jankovich's operation from Berth 74 to Berth 73A, Berth 51 and the Canetti's Building. The Harbor Department is requesting the relocation because the current location is in conflict with the Harbor Department's approved Port Master Plan and the development of the San Pedro Public Market at the current Ports O' Call Site. There is no impact to the General Fund.

RECOMMENDATION FOR CITY COUNCIL:

- 1. CONSIDER the Fifth Addendum to the certified San Pedro Waterfront Environmental Impact Report, and after consideration of said Addendum find that, in accordance with the provisions of the California Environmental Quality Act (CEQA) Guidelines Section 15162, the proposed Fifth Amendment will not result in any new significant environmental effects or any substantially more severe effects than previously analyzed in the certified Environmental Impact Report;
- APPROVE Harbor Department Resolution No. 17-8154 authorizing proposed Permit No. 930 with 2. The Jankovich Company; and
- 3. Return to the Board of Harbor Commissioners for further processing.
