Dear Councilmember Englander and members of the Public Safety Committee:

On behalf of 211 LA County (211 LA), I am writing to ask for your support for accepting the Department of Homeland Security – Countering Violent Extremism grant, and the excellent community-based work this grant will fund with the Building Healthy Communities Initiative.

211 LA is an independent non-profit organization (501c-3) that has served Los Angeles county by connecting people to critical health and human services since 1981. We receive over 400,000 calls every year from Angelenos in need of information, help, and support — many of whom are from extremely vulnerable or at-risk populations. Our staff is trained in assessment, crisis response, helping people navigate the complex service system, and applying a protective factors approach to building individual and family support and resilience.

211 LA is one of the sub-awardees of this grant, and the work we will be doing if approved includes building a connected network of community —based service providers who can provide culturally appropriate, multi-lingual, accessible preventive services to community members in need of assistance. This work will help ensure that no group is left behind when it comes to providing the connections, resources, and support networks needed to serve populations with social vulnerabilities.

We understand the fears expressed by some opposed to this grant, and initially shared their concerns. However, having worked closely with the Mayor's Office of Public Safety and the other community-based subawardees, we are confident that this grant represents an innovative, positive approach to CVE that poses no threat of religious or racial targeting. In fact, it builds on the work already being done by 211 LA and others to reach and support vulnerable populations in Los Angeles County, and to reduce social isolation, hate and violence generally through a protective factors public health approach.

I thank you for your consideration, and ask for your support for this grant.
