Dear Committee Members:

We declare that on May 1, 2018, a Brown Act noticed public meeting was held by the Eagle Rock Neighborhood Council (ERNC) with a quorum of 11 board members present and that by a vote of 10 yes, 0 no, and 1 abstention, the ERNC adopted the following as a Community Impact Statement:

Resolved, the ERNC supports Council File: 17-1311 regarding implementation of the recommendations in the 2017 FUSE Corps Fellow Report Concerning Street Related Infrastructure, in order to improve coordination among City departments, deliver better services in a more timely fashion, and improve relationships between residents and City government. Along with this approval, we request the City include and publicize an expedited schedule for review and implementation of the various elements addressed within CF 17-1311, as well as full and immediate disclosure of any elements not being pursued and why.

The ERNC learned more about the report's process and recommendations at the March 6, 2018 board meeting via Ms. Laila Alequresh. The ERNC also agrees with the Budget Advocates' March 2018 White Paper comment on page 3 of the Overview, which cites Ms. Alequresh's Report Concerning Street Related Infrastructure and notes that "[the] current system of stand-alone departments which do not effectively communicate with one another encourages duplication, inefficiency, and waste." The ERNC also agrees with the White Paper's statement finding compelling "the idea of transferring the Department of Transportation or many of its functions to Public Works where its functions can be integrated with other street services and its actions be held more accountable."

Further, as of May 1, 2018, the ERNC notes that your Committees have scheduled and subsequently continued four (4) hearings on CF 17-1311 since December 2017. The ERNC anticipates that your Committees will hold timely hearings on CF 17-1311.
