AUTHORIZING RESOLUTION

RESOLUTION OF THE COUNCIL OF THE CITY OF LOS ANGELES AUTHORIZING THE PREPARATION AND SUBMISSION OF A FINANCIAL ASSISTANCE APPLICATION FOR FINANCIAL ASSISTANCE FROM THE STATE WATER RESOURCES CONTROL BOARD FOR THE PLANNING, DESIGN AND CONSTRUCTION OF A PROPOSED ADVANCED WASTEWATER PURIFICATION FACILITY (AWPF) PROJECT PLANNED TO BE LOCATED AT THE DONALD C. TILLMAN AND GROUNDWATER SPREADING BASINS.

WHEREAS, the Bureau of Sanitation (LA Sanitation), acting on behalf of the City of Los Angeles (the "City"), intends to apply to the State Water Resources Control Board (the "SWRCB") to obtain financial assistance that is expected to be in the form of a low interest rate loan to assist in financing the planning, design and construction of a proposed Advanced Wastewater Purification Facility planned to be located at the Donald C. Tillman Water Reclamation Plant (the "Project") and Groundwater Spreading Basins (the "Project)"

WHEREAS, the SWRCB requires that the City's legislative body designate a City representative (the "Authorized Representative") and authorize the Authorized Representative to act on the City's behalf in submitting an application for financial assistance for the Project to the SWRCB;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Los Angeles as follows:

Section. 1. The foregoing recitals are true and the Council of the City (the "City Council") so finds and determines.

Section 2. The Director of LA Sanitation or written designee shall be the Authorized Representative to execute and file, for and on behalf of the City, a financial assistance application (the "Application") for assistance in the form of a loan evidenced by an installment sale agreement or other form of agreement (the "Financing Agreement") from the SWRCB, for the financing, design and construction of the Project. The Authorized Representative is authorized to provide the assurances, certifications and commitments required by the SWRCB for the Application.

Section 3. In the event the SWRCB approves the Application, the Authorized Representative is further authorized to work with City staff, the City Attorney and Bond Counsel to prepare the necessary documents to assist in financing the Project, including but not limited to the form of a financing agreement approved by the parties thereto ("Financing Agreement"), a supplemental resolution (the "Supplemental Resolution") supplementing that certain General Resolution duly adopted by the City Council on November 10, 1987 (the "General Resolution"), as previously supplemented

and amended, pursuant to which Supplemental Resolution the City Council would approve the Financing Agreement as a "Bond" under the General Resolution. The City Council hereby confirms that pursuant to the General Resolution, and subject to, among other things, the approval by SWRCB of the financial assistance to be provided to the City for the Project, the City has pledged the Revenues (as defined in the General Resolution) to the repayment of debt service on all Bonds to be issued pursuant to the General Resolution.

Section 4. This Resolution shall take effect immediately upon its adoption.
