Re: Homeless Encampments in Very High Fire Hazard Severity Zones

Dear Councilwoman Rodriguez:

I am writing to you on behalf of the Public Safety Committee for the Sylmar Neighborhood Council to convey a recommendation discussed and approved by our Committee on December 19, 2017 that we believe is critically important for the safety of our community members. Our Board discussed and approved our Committee's position on January 25, 2018 by a vote of (19) Yea, (0) Nay and (0) Abstain.

Over the course of the past 15 months or so, Sylmar has experienced several fires that appear to have originated from camping/cooking stoves or other illegal sources of fire in homeless encampments, as well as intentional acts by individuals. Businesses, residents, and homeless have been threatened countless times, particularly in areas of Sylmar mapped as Very High Fire Hazard Severity Zones (VHFHSZ). This is not an issue that is unique to Sylmar, as we are also aware of several fires with similar causation in the Sunland-Tujunga area and, most notably, the Skirball area. During our December 19th Committee meeting, we proposed that a multi-agency, cross-jurisdictional Task Force be created to regularly inspect and enforce a zero-tolerance policy for unlawful camping, illegal burning and trespassing in areas designated as VHFHSZs. Our community has long struggled with obtaining assistance with proactively removing encampments in these high risk areas.

As you know, Sylmar is at great risk for fires along our hillsides, is prone to extremely high winds, and has experienced several significant wildfires over the past few years (Marek, Sayre & Creek wildfires). The Skirball Fire in early December very publically highlighted the dangers that encampments pose to surrounding communities. Attached is a sampling of incidents that have occurred in Sylmar over the past 15+ months that have not garnered the same level of attention as the Skirball fire, but have nonetheless threatened our community.

We were pleased to see the announcement by Mayor Garcetti on January 5, 2018 regarding the creation of a Task Force that also appears to include connecting the homeless individuals affected by any such displacement with necessary resources and assistance. However, due the fact that many of the problem areas in Sylmar are also directly adjacent to County or Federal land, we ask that this Task Force be a cross-jurisdictional one. Particularly in

the area of the Pacoima Wash, we have experienced multiple incidents in which encampments moved from City to County to Federal lands, and our residents found it virtually impossible to obtain assistance with their removal. This specific area, as well as others areas along our hillsides, are mapped as VHFHSZs. We are aware of at least three fires that are related to encampments and/or illegally trespassing on these lands, so a multi-agency and coordinated effort is key.

Previously, we have inquired through your office as to where the 311 reports of encampments are directed, but this remains unanswered. A recent Daily News article indicated that reports should be directed to LAFD's Brush Clearance unit. We ask that you assist us with clarifying the process of reporting encampments along with the available enforcement mechanisms so that we may assist you through our work in the community.

We would also be pleased to have someone from your office attend our Public Safety Committee meetings on a regular or semi-regular basis. These meetings occur on the 2nd Thursday of each month at 6:30 PM.

Thank you for your work on behalf of our community and in advance for supporting this request. We stand ready to partner with you in moving this issue forward.

Possible Fire Averted Behind Olive View Medical Center

I didn't really feel like hiking today; it was windy, and cleaning up the ash & dirt in some of the 40+ properties we manage has been quite a workout. So I'm heading home and so is the Sun, and you know how pretty the mountains get with those last 10 minutes of daylight, and I love watching the sunsets from up there, so I'm passing Olive View Hospital, and I decide I can do a quick loop around the road where the trucks go up into the hills and get back to my van before it's totally dark. So I head out, walking briskly and I'm glad to be getting some exercise, and as I make a turn on that road up there, something pulled my attention in the distance: something glowing inside one of the abandoned buildings behind the hospital -- on the East side, near the Hartland Homes. I stopped to look carefully, and there was no doubt there were embers and flames inside the small building. I couldn't see anyone inside, but my assumption was somebody must be there, looking to settle for the night. I thought about going to the building and confronting them, and making sure the fire was put out. Then I thought, that could easily go sideways in many ways, and maybe make things worse. So I ran back to my vehicle, and by now I'm really getting that workout, and I'm thinking, there are always Sheriff and patrol cars around the hospital, I'll find one and show them where the issue is. And I did. To make an already-too-long story short(er), they went up, put the fire completely out, and then came back down to get a statement from me. Thank you, Officer Stewart, your partner whose name I'm sorry I don't remember, and the OV Security Dispatcher, Officer Martinez! They told me that from the way things looked, whoever started the fire was no longer there, and it appeared that he or she had left some time ago, and left the fire burning unattended -- and with gusting winds all around. What were they thinking?! They also told me there are "many" transients who take up refuge wherever they can, up in areas like that, and that they are always on the alert for issues like this. -----

This morning at 6:21 am, the LAFD was called by a security guard at Anthony Manufacturing (12400 Gladstone) as a homeless woman's encampment was on fire. She is going through her charred remnants this morning which is on the road leading up to the Sylmar Armory - soon to be the Women's Bridge Housing facility. This is the woman that I told you about a week or two ago. I had called LA Family Housing - Jaime Ruiz / Sylmar's navigator - to assist her. A photo coming soon. If not for the security guard's quick response and call to LAFD, there's no telling how much damage could have been done to nearby businesses. And nature blessed us with only 5 - 10 MPH winds this morning. The homeless woman is fine.

Recent arson arrest

Greetings Sylmar. As some of you are aware, there was a fire recently near Mission College and an individual arrested for arson. Here are the details: On November 14, citizens observed the Suspect within the flood basin near the college acting strangely. They ultimately watched him start a fire and flee on foot. Patrol officers responded quickly and located the Suspect in the wash. After forming a tactical plan, they approached the Suspect who would not comply with the Officers' commands. He pulled out a pocket knife, then opened the knife revealing a four inch blade. The Officers used a taser to subdue him and took him into custody without further incident or injury. He was booked for Arson and the LA District Attorney's Office subsequently filed several charges, including Arson and Exhibiting a deadly weapon. Not only did the patrol Officers involved show tremendous restraint and professionalism in my opinion, but the citizens who observed this crime and called 911 should be commended! This is a perfect example of seeing something, and saying something. They watched this individual's strange behavior and knew something wasn't right. They called 911 and gave a detailed description of him and his last known direction of travel. This lead to a significant arrest! Remember, if you see something, say something.
