## REVISED DRAFT ORDINANCE AMENDING SECTIONS 12.03, 12.04.09, 14.00 AND 16.05 OF THE LOS ANGELES MUNICIPAL CODE TO FACILITATE THE PRODUCTION OF PERMANENT SUPPORTIVE HOUSING

Honorable Members:

On March 2, 2018, this Office prepared and transmitted for your consideration, approved as to form and legality, a draft ordinance amending Sections 12.03, 12.04.09, 14.00 and 16.05 of the Los Angeles Municipal Code. (City Attorney Report No. R18-0063.)

On March 6, 2018, the draft ordinance came before the Planning and Land Use Management Committee (PLUM). PLUM approved a motion requesting the City Attorney to prepare two revisions to the ordinance. As requested, we have made those revisions in the enclosed revised draft ordinance, approved as to form and legality.

Specifically, the revised draft ordinance first adds the words "applicable Neighborhood Council" to the notification provisions in Subdivision (13)(c)(4)(i). Second, the revised draft ordinance adds the words "gas or oil well" to the first sentence of Subdivision (13)(g)(13)(iv) in Construction Standards.

At the request of the Department of City Planning, the revised draft ordinance clarifies several other provisions. First, the revised draft ordinance adds the phrase "or of a Major Transit Stop as defined in Section 21064.3 of the Public Resources Code" to the first sentence of Subdivision (13)(d)(2)(ii) in Automobile Parking Requirements. Second, the draft ordinance also adds the phrase "as measured to the main building" to clarify "front yard setback" in the first sentence of Subdivision 13(e)(1)(ii). Third, prior references to "Department" in the first paragraph of Subdivision 13(g)(13) and 13(g)(13)(iv) are clarified to refer to the Department of Building and Safety.

Finally, this Office also included a technical correction in Subdivision 13(g)(13)(iv) to make clear that both the database search and the report concerning potential for hazardous waste shall be provided to the Department of Building and Safety and made publicly available.
