While there is a need for these types of facilities, they are often pushing or exceeding the boundaries of what little regulation exists and are being used more as cash generators for their operators with little consideration of the surrounding community as evidenced by the attached letter from the Wilshire Park Association.

We would like the City to find allowable methods of regulation and permitting to ensure that these types of facilities can be a safe and welcome addition to our neighborhoods.

The residents of Wilshire Park Association are urging you and the City of Los Angeles to support the motion from Councilman Koretz (Council File Number 17-1426) on the regulation of sober living and detox homes in our residential neighborhoods.

In the spirit of maintaining the character and integrity of our residential neighborhood, Wilshire Park Association has pride in it Historical Preservation Overlay Zone (HPOZ) designation and one of our street has been designated Boulevard Heights in the National Registry of Historical Places.

The residential drug detox home located in Wilshire Park operates as a business and has a LLC designation. It is a 24-hour-facility and has no permanent residents living in the single family home. The residents, who are the patients/clients temporarily reside until their treatment is completed. The staff also do not reside at the detox home and leave after their shift to go to their own residences.

We encourage Council District Four, to analyze and support additional ordinances for regulating Sober Living/Detox Homes, similar to the ordinances passed in the City of Costa Mesa, CA. Some of these regulatory items include conditional use permits, licensing of sober living/drug rehabilitation homes, obtaining health permits, limits on the number of people residing in a home and limits on the number of sober living/detox homes in a neighborhood. These types of regulations would help inform and protect affected communities and facilitate better communication between the neighborhoods and nearby facilities, while ensuring vital treatment options remain safe and available.
