Dear Council President Wesson and members of the Rules Committee,

Transportation is now the largest source of greenhouse gas emissions in the state. If Los Angeles is serious about addressing air quality and the threat of climate change, we must not only invest in public transit but also allow more Angelenos to live near and use that transit.

By eliminating parking minimums and allowing greater density around transit stations, Senate Bill 827 will do just that. It is an essential part of our city and our state's efforts to fight climate change and it deserves the LA City Council's support.

I oppose Councilmember Ryu's anti-SB 827 resolution and ask you to do so as well. We need more homes near transit. We also need more clean transit near homes so expansion of the small bus program is a good idea as is expansion of the greenways near the river, by including bridges over the abutting streets, racks for bikes including the free bike share, transit stops, and pass throughs under. While I have your attention I also support overnight parking where it is currently prohibited. Open up those 10pm-6AM spots to mobile homes and trailers and cars and the river banks to tents with warnings that these are experimental programs and noise, trash, fighting, crime, or failure to use the readily availablw portapotties will end the program.

SB827 would take away local zoning authority and destroy the consistency and character of neighborhoods throughout Los Angeles (and the state) by allowing developers the unfettered ability to build massive buildings next to single-family homes. As a homeowner in Westwood, my home (and thousands of other properties) would be adversely affected by this legislation.

While I of course understand and support the need for additional housing in Los Angeles (and statewide), zoning always has been and should remain a matter of local jurisdiction. It **should not be mandated from Sacramento** to the benefit of developers and detriment of millions of

residential property owners who bought their homes with the expectation that zoning wouldn't change - or if it would, that they would at least have some say in that process.
