RULES, ELECTIONS, AND INTERGOVERNMENTAL RELATIONS COMMITTEE REPORT and RESOLUTION relative to establishing the City's position regarding AB 2980 (Gipson), which would amend the Medicinal and Adult-Use Cannabis Regulation and Safety Act (MAUCRSA) to allow two or more cannabis-licensed premises to share common areas.

Recommendation for Council action, pursuant to Resolution (Wesson - Price), SUBJECT TO THE CONCURRENCE OF THE MAYOR:

ADOPT the accompanying RESOLUTION to include in the City's 2017-18 State Legislative Program SUPPORT for AB 2980 (Gipson) which would amend the MAUCRSA so that two or more premises licensed to engage in commercial cannabis activity are not prohibited from sharing common use areas where no license privileges will be exercised.

Fiscal Impact Statement: None submitted by the Chief Legislative Analyst (CLA). The City Administrative Officer has not completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

At a special meeting held on March 23, 2018, the Rules, Elections, and Intergovernmental Relations Committee considered Resolution (Wesson - Price, and a report from the CLA relative to establishing the City's position regarding AB 2980 (Gipson), which would amend the MAUCRSA so that two or more premises licensed to engage in commercial cannabis activity are not prohibited from sharing common use areas where no license privileges will be exercised. The CLA report, attached to the Council file, provides additional background and a summary of the Resolution.

After consideration, and after providing an opportunity for public comment, the Committee recommended that Council adopt the accompanying Resolution. This matter is now forwarded to the Council for its consideration.
