TRANSPORTATION COMMITTEE REPORT relative to the establishment of parking restrictions along both sides of West 83rd Street between Isis Avenue and Hindry Avenue in Council District 11.

Recommendations for Council action, pursuant to Resolution (Bonin - Harris-Dawson):

1. RESOLVE, pursuant to Los Angeles Municipal Code Section 80.69.4 and California Vehicle Code Section 22507, to hereby prohibit the parking of vehicles that are in excess of 22 feet in length or over seven feet in height, during the hours of 2:00 am and 6:00 am along both sides of West 83rd Street between Isis Avenue and Hindry Avenue.
2. DIRECT the Los Angeles Department of Transportation (LADOT), upon approval of this action, to post signs giving notice of a Tow Away, No Parking restriction for oversized vehicles on the streets listed above in Recommendation No. 1.
3. AUTHORIZE the LADOT to make any technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

On January 24, 2018, your Committee considered a Resolution (Bonin - Harris-Dawson) relative to the establishment of parking restrictions along both sides of West 83rd Street between Isis Avenue and Hindry Avenue in Council District 11. According to the Resolution, there is a problem with oversized vehicles that are parked overnight on a segment of West 83rd Street in the Westchester community immediately adjacent to residences and businesses, which constrict travel lanes and create dangerous roadway conditions. After consideration and having provided an opportunity for public comment, the Committee moved to recommend approval of the Resolution as detailed in the above recommendations. This matter is now submitted to Council for its consideration.
