TRANSPORTATION COMMITTEE REPORT relative to establishing oversize vehicle parking restrictions along certain street segments in the Wilmington community.

Recommendations for Council action, pursuant to Resolution (Buscaino - Englander):

- 1. RESOLVE, pursuant to Los Angeles Municipal Code Section 80.69.4 and California Vehicle Code Section 22507, to hereby prohibit the parking of vehicles that are in excess of 22 feet in length or over seven feet in height, during the hours of 2:00 a.m. and 6:00 a.m., along West Mauretania Street between South Figueroa Street and North Wilmington Boulevard, West M Street between South Figueroa Street and North Wilmington Boulevard, West Robidoux Street between South Figueroa Street and North Wilmington Boulevard, West Papeete Street between South Figueroa Street and North Wilmington Boulevard, West L Street between South Figueroa Street and North Wilmington Boulevard, West L Street between South Figueroa Street and North Wilmington Boulevard, West Young Street between South Figueroa Street and the cul-de-sac, West Denni Street between South Figueroa Street and West Grant Street between South Figueroa Street and the cul-de-sac.
- 2. DIRECT the Los Angeles Department of Transportation (LADOT), upon approval of this action, to post signs giving notice of a Tow Away, No Parking restriction for oversize vehicles on the street listed above with the specific hours detailed above.
- 3. AUTHORIZE the LADOT to make any technical corrections or clarifications to the above instructions in order to effectuate the intent of this action.

<u>Fiscal Impact Statement</u>: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

<u>SUMMARY</u>

On September 21, 2018, Council considered Resolution (Buscaino - Englander) relative to establishing oversize vehicle parking restrictions along certain street segments in the Wilmington community. Resolution states this neighborhood is experiencing public safety issues associated with large vehicles that are parked overnight, constricting travel lanes and creating dangerous situations. Resolution recommends the establishment of oversized vehicle parking restrictions for the street segments listed above. Council referred Resolution to the Transportation Committee for consideration.

At its meeting held October 24, 2018, the Transportation Committee recommended that Council approve Resolution establishing oversize vehicle parking restrictions along the street segments listed above.
