

ORDINANCE NO. 185802

An ordinance amending Sections 57.105.6, 57.105.7.1, 57.105.7.8.4, 57.113.6.3.2 and 57.118.1.1, and adding Sections 57.105.6.36, 57.105.7.1.10 and 57.105.7.1.11 of Article 7, Chapter V of the Los Angeles Municipal Code to establish the fees for services related to required operational permits, and specific action or project permits.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Section 57.105.6 of Article 7 of Chapter V of the Los Angeles Municipal Code is amended to read as follows:

The Fire Code Official is authorized to issue Operational Permits for the operations set forth in Sections 57.105.6.1 through 57.105.6.36. The provisions of this section apply to permits which constitute authority for a continuing action by the permittee. No person or owner shall use any premises or engage in any activities described herein without having obtained a permit pursuant to this section.

Sec. 2. A new Section 57.105.6.36 is added to Article 7 of Chapter V of the Los Angeles Municipal Code to read as follows:

SEC. 57.105.6.36. HIGH-PILED COMBUSTIBLE STORAGE.

An Operational Permit is required to use a building or portion thereof as a high-piled combustible storage area exceeding 500 square feet (46m²).

Sec. 3. Section 57.105.7.1 of Article 7 of Chapter V of the Los Angeles Municipal Code is amended to read as follows:

Specific Action or Project Permits shall be required for the following specific action or project, as set forth in Sections 57.105.7.1 through 57.105.7.1.11.

Sec. 4. New Sections 57.105.7.1.10 and 57.105.7.1.11 are added to Article 7 of Chapter V of the Los Angeles Municipal Code to read as follows:

SEC. 57.105.7.1.10. EMERGENCY RESPONDER RADIO COVERAGE SYSTEM.

A Specific Action or Project Permit is required for the installation of or modification to emergency responder radio coverage systems and related equipment. Maintenance performed in accordance with this Code is not considered to be a modification and does not require a Specific Action or Project Permit.

SEC. 57.105.7.1.11. GATES AND BARRICADES ACROSS FIRE APPARATUS ACCESS ROADS.

A Specific Action or Project Permit is required for the installation of or modification to a gate or barricade installed across a fire apparatus access road.

Sec. 5. Section 57.105.7.8.4 of Article 7 of Chapter V of the Los Angeles Municipal Code is amended to read as follows:

Every application for a permit required by Sections 105.7.1.3 through 57.105.7.1.6, and 57.105.7.1.8 through 57.105.7.1.11 shall be accompanied by a fee or fees established by the procedure set forth in Section 57.113.6.3 of this chapter for any of the following:

Sec. 6. New Subsections 13 and 14 are added to Section 57.105.7.8.4 of Article 7 of Chapter V of the Los Angeles Municipal Code to read as follows:

13. Install and/or modify emergency responder radio coverage systems.

14. Install and/or modify gates and barricades across fire apparatus access roads.

Sec. 7. A new Subsection 39 is added to Section 57.113.6.3.2 of Article 7 of Chapter V of the Los Angeles Municipal Code to read as follows:

39. High-piled combustible storage, Section 57.105.6.36.

Sec. 8. A new Subsection (h) is added to Section 57.118.1.1 of Article 7 of Chapter V of the Los Angeles Municipal Code to read as follows:

(h) High-piled combustible storage.

Sec. 9. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in the three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.




