The Los Angeles, Department of Aging (LADOA) requests authorization to accept \$1,498,595 in FY 2018-2019 Senior Community Service Employment Program (SCSEP) grant funds from the California Department of Aging. SCSEP is an employment training program that provides classroom training to develop new work skills and on-the-job training to establish work experience.

LADOA respectfully requests approval of the following recommendations:

- Approve the FY 2018-2019 SCSEP Budget included as an attachment to this report and the Standard Agreement No. TV-1819-25 with the State of California, Department of Aging;

SUMMARY

LADOA requests approval of the Fiscal Year 2018-2019 SCSEP Budget and Standard Agreement with the State of California, Department of Aging. The SCSEP provides classroom training and part-time work experience in non-profit community service agencies to 164 City residents who are at least 55 years old, unemployed and have annual incomes that are no more than 125% of Federal Poverty Guidelines. Program participants, who are technically trainees, are paid under the City classification of Community Administrative Support Workers. The participants perform a variety of training duties that include clerical and office functions, food service, stock, and other community support work.

The FY 2018-2019 SCSEP grant award totals \$1,498,595, which reflects an increase of \$109,652 from the FY 2017-2018 SCSEP grant award of \$1,388,943 (Council File No. 17-0515). The general breakdown of expenses for FY 2018-19 is as follows:

As a condition of the SCSEP grant award, the City provides a grant match of \$281,307 in General Funds in the adopted FY 2018-19 City Budget, as follows:

- \$143,280 in Department staff fringe benefits and indirect costs
- \$138,027 in program participant fringe benefits (Physical Exams, Social Security match, Workers' Compensation)

Adoption of the report recommendations will result in no additional impact on the General Fund. Since program expenses are fully funded by the SCSEP grant and appropriated General Fund dollars, the report recommendations comply with the City's Financial Policies. Both the FY 2018-2019 SCSEP Budget and Standard Agreement TV-1819-25 are included as attachments to this report.
