The Los Angeles, Department of Aging (LADOA) respectfully requests approval of Fiscal Year 2018-2019 Senior Community Service Employment Program (SCSEP) Budget and Standard Agreement TV-18-19-25 Amendment #1. The grant award total of \$1,502,651 reflects a net increase of \$4,056 from the FY 2018-2019 original SCSEP grant award of \$1,498,595 approved by City Council on May 9, 2018 (C.F. # 18-0324). General breakdown of expenses is as follows:

4. Authorize the General Manager of the Department of Aging, or designee, to prepare Controller's instructions for any technical adjustments, subject to the approval of the City Administrative Officer, and authorize the Controller to implement the instructions.

SUMMARY

The SCSEP provides classroom training and part-time work experience in non-profit community service agencies to City residents who are at least 55 years old, unemployed and have annual incomes that are no more than 125% of Federal Poverty Guidelines. Program participants, who are technically trainees, are paid under the City classification of Community Administrative Support Workers. The participants perform a variety of training duties that include clerical and office functions, food service, and other community support work.

The original funding amount of \$1,498,595 supports 164 training slots for program expenditure. The modest \$4,056 increase will provide 306 additional training hours to eligible enrolled participants.

FISCAL IMPACT STATEMENT

The LADOA's proposed action authorizes the receipt of \$1,502,651 in Federal grant dollars for the SCSEP program.
