Re: Proposed Temporary Bridge Housing on Schrader Blvd: CF 18-0352

Dear Mr. Villanueva,

On behalf of PATH, I am writing in support of the potential crisis and bridge housing facility on Schrader Boulevard in Hollywood. With more than 30,000 people experiencing homelessness in our city, more than 23,000 – 73 percent – of our neighbors experiencing homelessness live unsheltered on any given night. This is an unacceptable crisis that impacts every neighborhood throughout Los Angeles.

The Los Angeles community called for more resources in support of our most vulnerable neighbors experiencing homelessness by passing Proposition HHH and Measure H. While Proposition HHH works to build supportive housing and Measure H programs enhance and expand the services available to people experiencing homelessness, Mayor Garcetti has recognized the need for emergency interim solutions. As a result, Mayor Garcetti has provided the City with the opportunity to embrace immediate services through investment in temporary crisis and bridge housing.

We, at PATH, practice the housing first approach and we see the efficacy of this approach in our clients and our tenants every day. However, we also recognize that the City is in crisis: Los Angeles is home to more than 30,000 people experiencing homelessness while the City also has a severe shortage of affordable housing. Without the available units to move people off the streets and into homes of their own, we, as a community, need to support the creation of interim emergency solutions.

As a neighbor of the City-owned LADOT Parking Lot at 1533 Schrader Boulevard, we support the use of the site as crisis and bridge housing. The location would provide space for our neighbors experiencing homelessness to be able to focus on accessing services and pursuing the housing navigation process. On-site professionally trained staff and security would ensure that the environment created at the potential A Bridge Home site would be optimal for both program participants and the neighborhood.

We, as a community, need an emergency solution for our neighborhood's crisis. The proposed location in Hollywood would play an integral role in helping our neighbors experiencing homelessness successfully move off the streets and into permanent homes.
