Dear Councilman Wesson,

On behalf of the Zen Center of Los Angeles (ZCLA), I write in support of the establishment of the proposed temporary homeless shelter in Koreatown. ZCLA has been a presence in Koreatown for fifty years since its establishment in 1967. As a Zen Buddhist temple and center, we serve the wider Los Angeles community and also a resident community of thirty people.

Over the past fifty years, we have lived through many phases of our neighborhood, including the LA Riots and the horrible street drug years of the 1980s. Now we are facing perhaps the toughest challenge of all: our unhoused neighbors living in tents on our sidewalks. We believe that every individual deserves a home and opportunities for a healthy and comfortable life in order to serve our communities.

Recently, through my work with the Mayor's Interfaith Council and in partnership with the Sanctuary of Hope, ZCLA opened its residential housing to a youth who had been homeless for three years while working and going to school. We are learning that it is not a simple matter to move off the streets and that services must be provided in order to make a successful transition.

Let's create an environment of compassion, hope and support in Koreatown and honor the mandate of the voters in passing Proposition HHH and Measure H.
