- 1. - 4. REQUEST the developer pay the full cost for any financial and economic analysis, consultants and any other reviews associated with the economic evaluation of this project.
- 5. AUTHORIZE the CLA to make any technical corrections, revisions, or clarifications to the above instructions in order to effectuate the intent of this action.
