M O T I O N

The General City Purposes Fund (GCP) portion of the proposed 2018-2019 City Budget provides funds for Heritage Month Celebrations and Special Events.

The LGBTQ Month - Valley Pride is an annual regional Valley festival event which should receive "Heritage Month" funding.

This effort is of special benefit for the residents of the City and deserves financial assistance from the City.

Sufficient funds will be available in the Council's portion of Heritage Month Celebration & Special Events line item in the GCP portion of the 2018-2019 City Budget for this purpose.

I THEREFORE MOVE that the City Clerk be directed to place on the Council Agenda for July 1, 2018, or soon thereafter as possible, the following recommendations for adoption:

1. That \$10,000 in the Council's portion of the Heritage Month Celebration & Special Events line item in the General City Purposes Fund No. 100-56 be utilized to fund any aspect of the LGBTQ Month - Valley Pride Heritage Month event.
2. That the City Clerk be directed to prepare and process the necessary documents and/or payments, directly with the vendor/service provider, and / or any other agency or organization, as appropriate, in the above amount, for the above purpose, subject to the approval of the City Attorney as to form, if needed; and that the City Clerk be authorized to execute any such documents on behalf of the City.
3. That the City Clerk be authorized to make any corrections, clarifications or revisions to the above fund transfer instructions, including any new instructions, in order to effectuate the intent of this Motion, and including any corrections and changes to fund or account numbers; said corrections / clarifications / changes may be made orally, electronically or by any other means.
