

ORDINANCE NO. 186401

An ordinance amending Section 12.04 of the Los Angeles Municipal Code to modify the boundaries of the West Adams-Baldwin Hills-Leimert Community Plan Implementation Overlay (CPIO) "Commercial Corridors" Subarea as shown in Ordinance No. 184794.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Section 12.04 of the Los Angeles Municipal Code is hereby amended to remove from the boundaries of the West Adams-Baldwin Hills-Leimert Community Plan Implementation Overlay (CPIO) "Commercial Corridors" Subarea established in Ordinance No. 184794 the parcels identified as "Properties removed from Commercial Corridors Subarea" in the portion of the Zoning Map attached hereto as Exhibit "A."

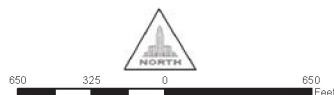
Sec. 2. This ordinance shall be operative on the effective date of the Exposition Corridor Transit Neighborhood Plan (Specific Plan) Ordinance.

- Properties removed from Commercial Corridors Subarea



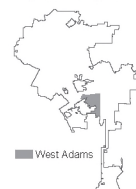
