

ORDINANCE NO. _____

An ordinance modifying the boundaries of the West Adams-Baldwin Hills-Leimert Community Plan Implementation Overlay (CPIO) "Commercial Corridors" Subarea as shown in Ordinance No. 184,794.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Section 12.04 of the Los Angeles Municipal Code is hereby amended by changing the zones and zone boundaries shown upon a portion of the Zoning Map attached thereto and made a part of Article 2, Chapter 1 of the Los Angeles Municipal Code, so that such portion of the Zoning Map shall set forth the zones and height districts for those areas shown in the attached map. This ordinance supersedes portions of the West Adams-Baldwin Hills-Leimert Community Plan Implementation Overlay (CPIO) "Commercial Corridors" Subarea in Ordinance No. 184,794.

Section 2. This ordinance shall be effective on the effective date of the Exposition Corridor Transit Neighborhood Plan (Specific Plan) Ordinance.

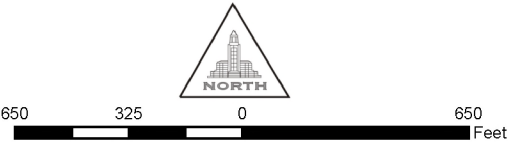
COMMERCIAL CORRIDORS

CPIO - Community Plan Implementation Overlay District

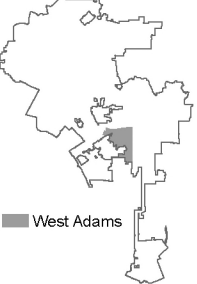
- Commercial Corridors CPIO Subarea Boundary

Section 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
