

ORDINANCE NO. _____

An ordinance establishing the boundaries of a Specific Plan known as the Exposition Corridor Transit Neighborhood Plan in a portion of the West Los Angeles, Palms-Mar Vista-Del Rey, and West Adams-Baldwin Hills-Leimert Community Plan areas.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. The City Council hereby establishes and adopts the attached boundaries for the Exposition Corridor Transit Neighborhood Plan (Specific Plan) as the area bounded by heavy lines in the Plan Boundary Map attached hereto and set forth in Section 1 of the Plan.

Section 2. This ordinance shall be effective on the effective date of the Exposition Corridor Transit Neighborhood Plan (Specific Plan) Ordinance.

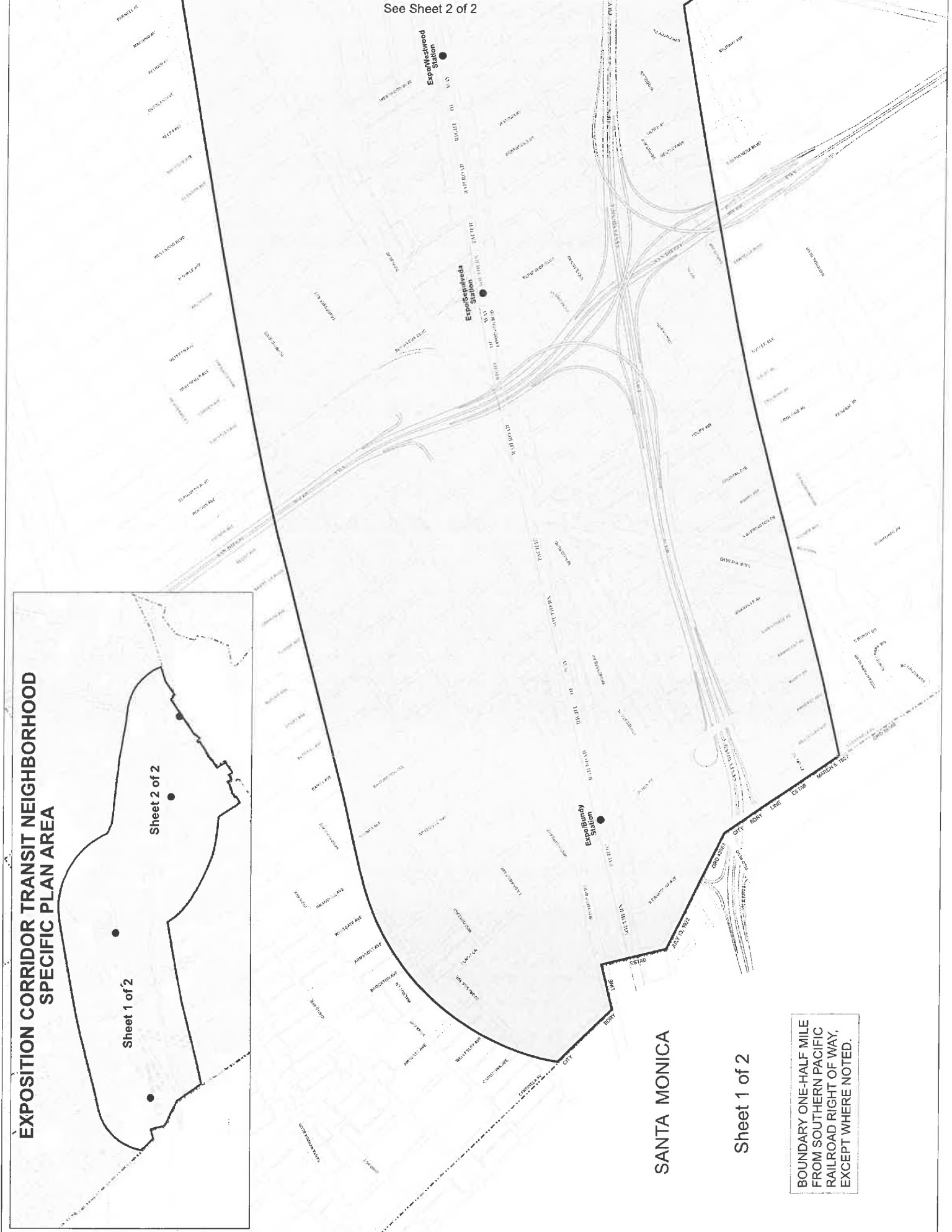

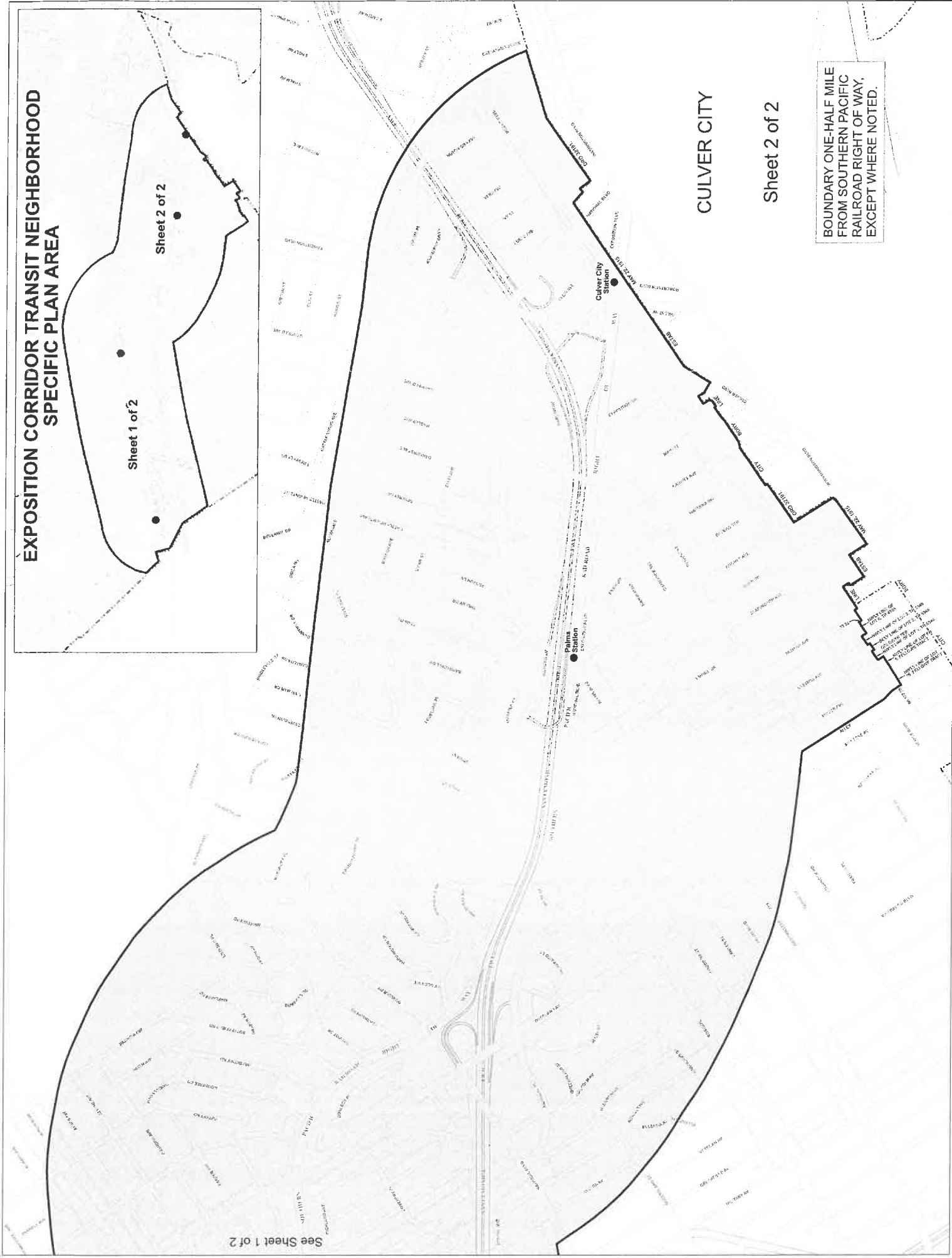
